Applicant described the need and urgency for a temporary generator until permanent one arrives.

Board and Applicant discussed the application with questions to the Applicant.

R. Hart made the following motion:

That in Case BBA22-1004, the appeal of the Building Official's decision that the work performed at 1100 Broadway is GRANTED relief from article 700.3 of the 2017 National Electrical Code, and the Building Board of Appeals REVERSES the Building Official's decision for the reason that the applicant has proposed a temporary equal form of construction. With the stipulation that this is intended to be a short-term bridge and with the assurance that the interim, temporary system will be as effective and as responsive as if it was the permanent code-mandated fixed emergency generator conforming to the provisions of NEC 700.3(F) and that this appeal and progress towards solution would be revisited by the October 19, 2023 meeting. and that the applicant will provide a status update report of the system's operation and anticipated completion date should the permanent generator installation be delayed for Building Department review.

With a vote of 4 - 0, Chair P. Darling declared the motion passed.
