**6. PUBLIC COMMENT (Persons may speak for three minutes about an item that is NOT listed as a public hearing on this agenda. Please state your name and address for the record.)**

*Adam Jaskiewicz, Las Vegas Drive, spoke in support of the plan, recommended beginning zoning work promptly, handled in-house with TC1 and noted concerns about streetscapes in the right-of-way.*

*Tom Lyon, 2417 Londonderry Road, opposed changes to residential land uses that allow businesses, citing uncertainty about housing affordability.*

*Peter Jackson, 10 Geddes Heights, questioned whether the plan will meet its objectives and noted support of public green space but raised concerns about building heights near those areas.*

*Jeff Crockett, Ward 4, pointed to Boston Edison as an example of honoring community history and noted the plan does not address the benefits of historic districts.*

*Julie Ritter, stated the Minneapolis plan is a poor comparison, urged senior affordable housing, and criticized tax focus.*

*Tricia Hackney, The Crossings, believes the plan reduces affordable starter homes and replaces them with higher-cost housing and noted issues with investor pressure on homeowners.*

*Greg Monroe, Ward 5, thanked the city for reading all the public comments, urged incentives to protect mature trees, and raised concerns about expanded by-right zoning's impact on natural features.*

*Tom Stulberg, 1202 Traver Road, raised concerns about rezoning The Dean as D-1 while surrounded by D-2, noting this assumes plan approval and that D-1 allows short-term rentals, which may affect affordability.*

*Gabrielle Bowyer, 1721 Newport Road, expressed concern that the plan does not adequately consider middle-class needs.*

*Ken Garber, 28 Haverhill Court, terms like resilience and circular economy overlook core issues, opposed new fossil fuel infrastructure,*

*and urged the plan to prioritize eliminating emissions.*

*Kirk Westphal, 3505 Charter Place, noted constrained housing supply, said new homes need subsidies, and urged fast in-house zoning work.*

*Dennis Burke, South Fourth Avenue, spoke in support of higher-density housing in principle but cautions against assuming it lowers rents, and opposes converting office space to housing.*

*James D'Amour, argued the plan should not replace the Natural Features Plan, as it lacks detail on the Greenbelt Ordinance, and minimizes environmental planning by creating manufactured consensus.*

*Alex Lowe, 2532 Pittsfield Boulevard, observed that if this becomes nonconforming, it may suggest that setback regulations need updating.*

*Gabrielle Bowyer, 1721 Newport, observed many residents are unaware of the plan and notes responses have been limited.*

*Ken Garber, 28 Haverhill Court, commented the circular economy is debated and questioned the extent of resilience measures.*

*Rita Mitchell, raised concerns about long-term tree retention and requested findings from the Urban Forestry Management Plan.*

*Alex Lowe, Pittsfield Boulevard, referenced a report of increased tree cover in Ann Arbor and noted the absence of density and height minimums.*
