*Deputy Planning Manager Kelley reported for the Tuesday, July 1, 2025 City Planning Commission meeting:*

*900 Briarwood Circle (SP24-0008) – Site Plan for Planning Commission Approval: Revision of the previously approved site plan (SP23-0005) for the large format retailer. A reduction of building size from one 100,000 SF 2-level building to a 60,000 SF 1-level building with an adjacent 15,880 SF small retail building. No other changes to the site are proposed. Zoned C2B (Business Service District). Ward 4.*

*1208 South University (SP24-0029) – Site Plan for Planning Commission Approval: An update to the original site plan that incorporates the adjacent parcel located at 610 S Forest Ave. The project*

*will be an 18-story mixed-use residential and retail tower. The proposed development consists of 259 rental apartment units and 5,120 SF of ground-level commercial tenant space. The building incorporates storage for 52 bikes and 83 garage parking spaces. Parking and loading have been concealed off the south side alley. Zoned D1 (Downtown Core District). Ward 3.*
