City Council

City Council will meet in caucus the Sunday prior to each regular session at 7 p.m. in the Larcom Basement Conference room.

CALL TO ORDER

Mayor Taylor called the meeting of the Ann Arbor City Council to order at 7:02 p.m. in the Washtenaw County Building, 220 N. Main St., board room.

MOMENT OF SILENCE

Council stood for a moment of silence.

AC COMMUNICATIONS FROM THE CITY ADMINISTRATOR

City Administrator Steve Powers reported on the following:

The Ann Arbor Board of Realtors notified the City that they are presenting the City with an award of Environmental Excellence for the City's Greenbelt Program.

Staff will report out on issues that were on hold waiting for action from the lame duck Legislature. Council can expect to receive information on some of these outstanding issues in the next week.

The City Council's next Work Session is a joint work session with the City Planning Commission. The meeting will take place at the CTN Studios, 2805 S. Industrial Highway. The meeting will be held January 12 at 7 p.m.

City Council will return to City Hall Council Chambers at their next regular session, Tuesday, January 20. Mr. Powers noted that the meeting will be held on Tuesday, due to the Martin Luther King Jr. holiday.

Mr. Powers introduced Larry Collins, the City's new Fire Chief, who was in attendance. A swearing-in and welcome ceremony will be held at Fire Station One on Friday, January 9 for the new chief.

1. Kathy Griswold - Pedestrian Crosswalks Ordinance (C-1)

Kathy Griswold, 3565 Fox Hunt, spoke about the proposed Pedestrian Crosswalks Ordinance and some of her concerns.

2. Blaine Coleman - Boycott Israel

Blaine Coleman, 1501 Ardmoor, urged Council to take action and boycott Israel.

3. Margaret Lynch - Deed to 3501 Stone School Road

Margaret Lynch, 805 W. Huron, clarified some comments that were previously made regarding her ownership of property at 3501 Stone School Road. She stated that in 2013 she deeded that property to the non-profit MISSION. She also stated she felt it was inappropriate to discuss the purchase price of her home on Huron Street at a Council meeting.

4. Caleb Poirier - Correcting Stephen Kunselman

Caleb Poirier, an advocate for the homeless, stated the Washtenaw County Election Commission approved various forms of proposed recall language against Mr. Kunselman, at their meeting this afternoon. He stated the recall effort is not an effort of MISSION, but of various individuals.

CC COMMUNICATIONS FROM COUNCIL*COUNCILMEMBER LUMM*

Councilmember Lumm reported that there was still time to sign up to donate your Christmas tree to charity for a Huron High School fundraiser. Trees would be picked up on Saturday, January 10 and would eventually be chipped up for pathways at Gallup Park.

Councilmember Westphal noted that residents could sign up by contacting localgirl@comcast.net and they were taking names until Friday.

COUNCILMEMBER EATON

Councilmember Eaton stated that Councilmember Anglin was in Florida for a family emergency. He stated Councilmember Anglin sends his regrets for missing the meeting.

COUNCILMEMBER GRAND

Councilmember Grand reported that the City won two awards from the Michigan Parks and Recreation Association for its parks. One award was for the design of the Vet's Park Skate Park for its innovative design and the second was for the citizen pruner program.

Councilmember Grand stated she and Councilmember Briere had their first meeting as liaisons to the Ann Arbor Public Schools, with City Administrator Powers and Superintendent of Schools, Dr. Swift. She stated it was a very informative meeting and that both parties plan to share resolutions of their boards that are of mutual interest.

A public hearing was conducted on the proposed amendment to Chapter 55 (Zoning), Section 5:10.20.A Downtown Character Overlay Zoning Districts Building Massing Standards. Notice of public hearing was published December 11, 2014.

The following people spoke at the hearing:

Ted Annis, 414 S. Main, spoke in opposition to the D1 zoning.

Scott Bonney, architect hired by the property owner of 425 S. Main Street, spoke in opposition to the City further down-zoning the property.

Ethel Potts, 1014 Elder Blvd., spoke in opposition. She stated this is the latest attempt to make the D1 and D2 zoning workable, but noted problems with setbacks and sidewalks.

Andy Klein, representing KRG Investments, the owner of 425 S. Main, spoke in opposition to the continual down-zoning of his property by the City.

An unidentified property owner on S. Fourth Avenue

Kathy Boris, 1726 Charlton, spoke in support of the ordinance changes, stating a down-zoning was needed.

Chris Crockett, 506 E. Kingsley Lane, representing the Old Fourth Ward, stated D2 is the only choice for 425 S. Main.

Rita Mitchell, 621 Fifth, encouraged Council to keep the D2 zoning for 425 S. Main.

Steve Kaplan, 418 E. Washington, expressed concerns about the zoning of 425 S. Main.

Ray Detter, 120 N. Division, urged Council to get true public benefits for the development of 425 S. Main. He stated there were some "mistakes" in the A2D2 process.

Alan Haber, Third Street resident, stated D1 is too high for 425 S. Main. He urged Council to keep the D2 zoning.

There being no further comment, the Mayor declared the hearing closed.

A public hearing was conducted on the proposed amendment to Chapter 55 (Zoning), Rezoning of 1.1 Acres from D1 (Downtown Core Base District) to D2 (Downtown Interface Base District), 425 South Main Street City-Initiated Rezoning, 425 South Main Street. Notice of public hearing was published December 18, 2014.

The following people were present to speak at the hearing:

Scott Bonney, representing the owner, stated that the reduction from 180 feet to 60 feet is too extreme.

Ethel Potts, 1014 Elder, spoke in opposition to the development of this parcel as proposed.

An unknown speaker expressed concerns about the varying heights allowed on each side of the property. He stated many in the neighborhood understood that D2 only allowed 60 feet in maximum height.

Andy Klein, representing the owner, reminded Council that his parcel has already been the subject of multiple down-zonings. He spoke in opposition to a further reduction to the property's zoning.

Ted Annis, 414 S. Main, stated his opposition to the parcel being developed as proposed.

Ray Detter, representing the Downtown Citizen's Advisory Council spoke in opposition to the development of the parcel.

Alan Haber stated there is confusion about D1 and D2. He stated the height limit should be 60 feet maximum. He reminded Council of the lesson of 413 E. Huron.

There being no further comment, the Mayor declared the hearing closed.
