The committee is pleased to welcome David Penland as a new member. Thank you Member Penland for volunteering as a steward of Elizabeth Dean's legacy and gift to Ann Arbor's urban forest!

BUSINESS

Bicentennial Park - Adam Fercho

Adam Fercho, Park Planner, updated the committee on Bicentennial Park.

They have a contractor lined up to do the work. They are currently fundraising for this project as this park's updates will be privately funded and not paid for with Parks Millage dollars.

Parks has the following request to the committee:

Fund the planting of 13 2.5-inch caliper trees in the park. They request a 2-year warranty on the trees.

Staff will reach out to the city's tree planting contractor for a quote for the trees and a 2-year warranty.

Note: the trees will be planted in either Spring 2025 (FY2025 impact) or Fall 2025 (FY2026 impact). The committee has accounted for the budget impact in both fiscal years in their long-term planning document.

Wieland moved to support the Bicentennial Park project to plant 13 trees, not to exceed \$11,000.00. Sundry seconded. Motion passed unanimously.

Leslie Science and Nature Center - Adam Fercho

No update on this project at this time. Adam will return to the next meeting with an updated plan.

Planting Contract Update - Tiffany Giacobazzi

The Elizabeth Dean Fund Committee and Forestry Street Tree planting contracts cannot be bundled. Retainage cannot be collected from the Elizabeth Dean Fund, and is required on Forestry contracts.

Mushroom Park Update - Tiffany Giacobazzi

Forestry reviewed the trees at Mushroom Park. The large white oak is too far gone to be worth further monetary investment. The Scotch pines are listed as invasive, so money cannot be spent on them unless it's to fund removal of the trees. The committee does not wish to commit funds to removal of the trees at this time.

Huron River Days Update - Richard Wieland

Members Nybell, Wieland, and Curtis staffed the table at the event. Attendance was lower this year due to construction at the usual venue and the consequent relocation of the event. Even so, there were a lot of people in attendance. Nybell recommends the committee network more with other related organizations.

Tree Warranty Discussion - Richard Wieland

Staff updated the committee on warranty inspections of the previous

fiscal year's tree planting projects.

Staff suggested one project the committee should consider is inspecting previous Elizabeth Dean Fund Committee planting projects and replacing trees that have subsequently died. The committee liked this idea. It will be considered for future planting projects in the long-range 3-year plan.
