**The November 13, 2025 Historic District Commission meeting minutes were unanimously approved by the Commission and forwarded to City Council.**

**I. REPORTS FROM COMMISSIONERS**

*Chair Rochlen noted that he gets questions from members of the community regarding how the Comprehensive Use Plan specific to Historic Districts.*

*Chair Rochlen noted that on page 39 of the Comprehensive Land Use Plan mentions Historic Districts. He noted that participants at a CLUP community meeting called for a balanced approach between development and what makes Ann Arbor a place to live. While there was general agreement that increased density is needed to achieve the city's goals for more housing, for a walk able instead of car dependent streets, and to preserve green space. Many also emphasized the need for community amenities, green spaces, historic districts and the scale of new development are considered.*

*Chair Rochlen also mentioned how goal one of the plan notes that they want to increase the housing supply. Historic District boundaries and development will continue to follow the standards and guidelines*

*established by the Historic District Commission. The city's 15 historic districts are legally protected to with the purpose to protected with the purpose to preserve the city's buildings in places of historical and cultural significance for generations. An outcome from decades of legislative actions of the city in the effort to protect they also regulate new development in a manner that can be more limiting than underlying zoning regulations alone. As a result, while these zones are some of the city's most beloved they are often limited in provided new housing units compared to similarly zoned properties elsewhere.*

*Chair Rochlen noted that he wanted to make commission aware of how Historic Districts are mentioned in the Comprehensive Land Use Plan.*
