ALLEGATION: I am submitting this formal complaint regarding my arrest on April 25, 2024, during which I experienced property mishandling, lack of investigation into theft, and failure to address a mental health crisis involving my boyfriend. Additionally, I believe my disability and impaired state were not properly considered by the officers involved. Concerns: Mishandling of My Personal Property: During my arrest, Officer [Name] indicated that they had possession of my phone. However, I later discovered that my boyfriend had taken it, leaving me unable to contact anyone for assistance. Additionally, \$900 was taken from me by my boyfriend while I was in a blackout state. No effort was made by law enforcement to recover my stolen property. Failure to Address a Mental Health Crisis: While I was incarcerated, my boyfriend, who was intoxicated and emotionally distressed, attempted suicide. Despite clear warning signs, officers failed to assess or intervene in his mental health crisis, which could have prevented this tragic event. Lack of Investigation: No investigation was conducted into the theft of my phone and money, nor was there any effort to address my boyfriend s crisis. These oversights have had lasting financial and emotional consequences for me. Request for Action: Given these issues, I formally request the following actions: A review of the officers' actions, including their handling of my property and failure to investigate the theft. An examination of the lack of response to my boyfriend? s mental health crisis and whether proper protocols were followed. Consideration of my disability and impaired state in any legal proceedings related to this incident.

DISPOSITION STATUS: Closed



AAPD RESPONSE: A thorough review of this incident showed there were no policy violations by officers and the complainant wished to withdraw his complaint. Therefore, an internal Personnel Complaint was not generated, and this allegation is closed.

ALLEGATION: I am writing to formally file a complaint regarding animal neglect that occurred while I was incarcerated for 22 days and subsequently left homeless due to court orders. During this time, my two cats, [Cat Names], were entrusted to three individuals chosen by my boyfriend, [Boyfriend's Name]. I have substantial reason to believe that these individuals neglected my pets, causing them harm and ultimately leading to their rehoming without my knowledge or consent. This situation has caused me significant distress, and I am requesting a formal investigation into the matter. Specifically, I want answers regarding: The conditions in which my cats were kept while under the care of these individuals. Whether their basic needs (food, water, medical care) were adequately met. The circumstances surrounding their rehoming and whether any legal violations occurred. I understand that law enforcement may already be involved in related matters, and I am seeking your assistance in ensuring accountability for those responsible for this neglect. Additionally, I request guidance on: The steps I can take to assist in this investigation. Whether any legal action can be pursued against those responsible. I expect a written response to this complaint within [reasonable timeframe, e.g., 14 days]. If I do not receive an adequate response, I will consider escalating my complaint to other authorities, legal representatives, or advocacy organizations.

AAPD RESPONSE: To date the complainant has not made an animal neglect incident report with the AAPD. The AAPD will take a report and investigate it if/

He told me that he would not answer that. Moreover, he said that he would not get into that. I asked him later in the conversation if it would be possible for him to write down his badge number. He said that it would not be possible for him to do that. When I asked him if it was because I was a person of color he seemed to get upset and said that he was a person of color and then said, ""Oh so it does not count because I am not Black."" He seemed to mutter something under his breath. Then he turned around and decided to walk out of the door in the lobby area of the floor of the apartment. The other two officers followed. I then asked him again what his badge number was. And he said it as he was walking away. I was barely able to make it out. Lieutenant Tassin had a card on him, and a penwhy could not he just write Officer Pitt's badge number down. I have Officer Tassin's badge number-190. Or why could Officer Pitt not ask Officer Tassin to write down his badge number? Why did Officer Pitt not ask Officer Hoak to write down his badge number? Why did Officer Hoak/Tassin not speak up and decide to write down Officer Pitt's badge number? I had asked Officer Hoak for his number. Why could he have not written down his number? Maybe their numbers were 316 and possibly 129? I cannot tell which number belongs to who. Officer Pitt did not write down his badge number because he did not want to help me-that's why. I think he also revealed his truth regarding his views on Black people."

Oversight reform to prevent others from enduring what I went through. I am speaking up because what happened to me should never happen to anyone. I deserve justice and I am not alone.

DISPOSITION STATUS: Closed

AAPD RESPONSE: While Mr. Hansen does not list the police department associated with his complaint, AAPD Professional Standards previously investigated complaints by Mr. Hansen, which were later rescinded, related to his arrest on 04/25/2024. Those complaints, PR24-019, CC24-027, IC25-012 and IC25-013, were thoroughly investigated and uploaded to the ICPOC portal. A thorough review of those incidents showed there were no policy violations by



officers involved. The Ann Arbor Police Department cannot address issues Mr. Hansen may have had while at the Washtenaw County Jail or at the hospital. A review of Mr. Hansens' numerous emails indicates he may be experiencing mental health and/ or substance abuse issues. AAPD Professional Standards has forwarded this information to our Community Engagement Unit to facilitate outreach with Community Mental Health (CMH), to provide Mr. Hansen with additional or more appropriate services outside the police department. There are no policy violations, and this allegation is closed.

The damage to my vehicle was substantial. According to my auto repair shop, after they open the car, they found h to e damage was extensive and required three weeks of repairs.

AAPD RESPONSE: Lt. Petterle called and spoke with Ms. Li and explained the officer actions on this call. Officers have discretion as it relates to issuing a citation or not. Ofc. Long chose not to issue a citation to the at-fault driver involved but still marked that driver at-fault in the state reportable crash report. Lt. Petterle explained how Michigan is a no-fault state (as it relates to insurance), and that Ofc. Long found the other driver responsible for the crash regardless of whether a ticket was issued or not. Ms. Li was also informed that Ofc. Long used her discretion not to write her a ticket as well, as Ms. Li did not have her driver license or proof of insurance in her possession at the time of the crash. Ms. Li stated she understood but still believed everyone, including herself, should have received a ticket. There are no policy violations, and this allegation is closed.

We are third in the line of traffic and there has been no attempt by the police to communicate with us about what's going on or estimate times or provide any sort of solution. It will also be submitting a complaint to the fire department involved because they have completely failed for the last 45 minutes to do anything about the fire but walk around and talk. If there is time for them to walk around and talk, there is time for them to at least communicate about what is going on. The fumes are so bad that it has triggered a blindingly painful migraine for me and I me stuck in the car on a 96 degree day on the verge of throwing up. This situation has been mishandled at best, with a shocking amount of arrogance and refusal to respond to the situation by the police.

ALLEGATION: My name is Sertac Yondem, and I am filing a formal complaint against the Ann Arbor Police Department regarding a false arrest and mishandling of an incident that occurred on March 29, 2025, between 1:00 AM and 2:50 AM at 214 W Washington Street, Ann Arbor, MI. I was falsely accused by my exgirlfriend after an argument where I refused to give her my phone. She was intoxicated, physically assaulted me (choked me), blocked me from leaving, and sat in the driver seat of my car trying to drive it while I was recording everything for my safety. I have video and photo evidence of this. Despite this, the responding officers: Refused to watch my video evidence, Ignored my testimony, Arrested me solely based on her false claims. What's even more frustrating is that the location of the incident 2 a public parking garage at 214 W Washington 2 is covered by multiple surveillance cameras. Those cameras would clearly show what happened and support my version of the events. However, I was never told that any footage was reviewed, and I believe the officers failed to request or preserve it. I was held for approximately 7 hours and released. Two days later, ICE arrested me based on the pending charge. I was detained for months, denied bond (due to that arrest), and ultimately withdrew my asylum case and was deported 2 even though the charge was dismissed about a month later. My exgirlfriend even contacted my boss after my ICE detention, saying she regretted what happened and was willing to write a letter to help, but then disappeared and never followed through. At my immigration bond hearing, my lawyer mentioned the dismissal but did not explain the facts of the incident or provide my video. I was labeled a 2danger to the community 2 and held based on a false



arrest. This complaint is being submitted to the Ann Arbor Police Department and the Independent Community Police Oversight Commission, and I request that: The officers' actions be reviewed, The surveillance footage from the parking garage on March 29 be preserved (if still available), An investigation be opened into this false arrest and its consequence

He was trespassed from breakfast at the request of Church staff and ultimately arrested for disorderly conduct and MDOP (spray painting a mailbox). There are no policy violations, and this allegation is closed.

ALLEGATION: My mom punched me hard 3 times on my left shoulder when she had thought that I wasn't paying attention to her explanation of the content of a social media video. I asked her why was a person in the video laughing weirdly? I had told her for a while before to not go on long rambles and I felt that she was going to do it this time so I told her "Stop" multiple times. Then, she came up to me, pretended like she was gonna do something, and then unexpectedly did it. This is not the first time where she has made physical moves towards me that hurt. I had told her several times in the past to stop hurting me when there's no threat anywhere. Because this had been going on for years, I got sick and tired of taking it, swallowing it up and feeling hopeless and defenseless so I called the cops so she can just be given an explanation and be held accountable. I texted 911 because inflicting harm physically is assault (I didn't specify physical assault, mistake on my end). Both of the officers did not cooperate with me at all. They kept doubting what I had brought them for, did not believe most of the stuff I was telling them, were one-sided, repeatedly made false accusations that I was interrupting over them, cut me off numerous times when I did try to say a full sentence, told me to eat up their remarks and that I did everything wrong and was lying, forced me to apologize while not telling me that they have told my mom to stop/step back a bit, made me say something I did not mean, mocked me for not giving precise math percentage numbers and being super broad, justified domestic violence and said that it's just a part of growing up, didn't acknowledge any form of equal treatment and that parents get to have a free pass from doing anything to their son/daughter, falsely accused me of having a disability, said that



I need therapy for the way I'm treated, doubted me for being unable to reenact the punch with the black officer when I had already told them right before that I wasn't able to, repeatedly made false remarks that it was a tap and not a few punches, didn't seem to get the idea that not everyone is a tall strong and healthy person and that not everyone has the same pain tolerance (also that doesn't make you sensitive), said that I didn't speak to mom once when the cops came (true) but when I did start to speak to her they falsely accused me of interruption (ok, cool logic mister), and whispered things to each other and to mom that they didn't want me to hear (for what reason other than not being transparent?). Absolute jerks who are stuck in the past and are inconsiderate. They also make my mom play the victim instead of coming to a mutual agreement where she just stops doing one thing and calling it there. I do admit that calling the police for this is kinda pushing it but as I said above I had no other resources. This situation is all over the place. All I wanted out of this was some questioning, but instead I got cops who think that they know all the answers and the gist of everything. I have stated above where I was wrong, but the cops were bullying me for most of the interaction. Sad. No one deserves to lose their livelihood over anything. People just need to be held accountable and not stand over people who they can stand on and stand on them anytime they have the opportunity.
