1 CALL TO ORDER

Chair Paige Morrison called the meeting to order at 4:03 p.m.

2 ROLL CALL

J. Landefeld, Parks and Recreation Services Deputy Manager called the roll.

3 APPROVAL OF AGENDA

Approved unanimously as presented.

4 FIRST PUBLIC COMMENT

James Daniel, 2769 Arrowwood Trail, Ann Arbor, inquired about the policy for use of park land adjacent to other properties.

J. Landefeld explained that the Parks and Recreation Department and the City Attorney's office are going to contact Arrowwood Co-Op to resolve park land use issues.

Priscilla Cheever, 267 S Wagner Road, Ann Arbor, expressed concern with the amount of park land currently being considered to be acquired by the city and explained that she believes that the city should be more aggressive with acquisition.

Patti McCall Tetra Tech, provided an update on the Leslie Science and Nature Site highlighting the following items:

- *The initial depression determined to be not man made*
- *Target areas*
- *49 investigation points*
- *80 soil samples analyzed*
- *Vapor intrusion testing*
- *Remediation*

Councilmember J. Hayner inquired about migration and pond contamination.

McCall explained that there is a lot of clay in the area, and that she is working to determine where the contamination ends.

Commissioner M. Appel inquired about challenges with remediation.

McCall answered that there is negative pressure in the basement and there have been flooding issues.

Commissioner R. Galardi inquired about rainwater impacts with the contaminants present.

McCall answered that the compounds present are not very mobile and aren't likely to be disrupted by precipitation.

Councilmember J. Hayner inquired about cost for remediation as well as state involvement in remediation.

D. Delacourt, City of Ann Arbor Community Services Area Administrator, answered that the cost for remediation will exceed the approved contract

amount with Tetra Tech, that the city has been awarded. Delacourt also explained that there is both county and state involvement in the remediation.

McCall explained that that due to the property being acquired by the city prior to environmental standards being in place, the site is considered an "orphan site" and if the city was not working to remediate the area then the state would be responsible.

6-B 19-1574 American Legion and Veteran’s Memorial Park Flagpole Project

H. Hanzel, City of Ann Arbor Landscape Architect, presented information on the American Legion & Veteran’s Memorial Park Flagpole Project. She introduced Dave Draper and Doug Harvey from the American Legion Post 46.

Draper explained that the flagpole project is extremely meaningful and he expressed gratitude for the project being finalized.

7-A REPORT FROM PARKS AND RECREATION MANAGER

J. Landefeld reported that Fuller pool will remain open for two weeks after Labor Day, that the Mack Pool improvements are complete, Riverside Path will be repaved starting after Labor Day, and that there is an exhibit at the Ann Arbor District Library for the 100th anniversary of the Ann Arbor Farmer’s Market. He announced that there will be a Farm-to-Table fundraising dinner on September 20th, where the funding raised would be used for mini grants for Farmer’s Market vendors.

M. Appel inquired about the work at Riverside Park.

H. Hanzel explained that a full base removal will take place and the stones will be replaced.
