**6. PUBLIC COMMENT (Persons may speak for three minutes about an item that is NOT listed as a public hearing on this agenda. Please state your name and address for the record.)**

*Rajeev Batra, 2885 Renfrew Street, spoke in opposition to increasing density in residential areas and urged a pause to the plan, and greater engagement with the public.*

*Mary Durfee, 1052 Olivia, expressed support for walkable amenities within neighborhoods but cited concerns with viability of retail in mixed use buildings.*

*Brett Henderson, 1416 Brooklyn Avenue, spoke to parking concerns with new development under current requirements, citing challenges around traffic and density. Concerns also cited around tree removal and stormwater management along with changes to R1 and R2 zoning.*

*Andy Flint, 3425 Andover Road, spoke in support of retaining single-family zoning in the Comprehensive Plan.*

*Warren Williams, 2708 Lower Road, grew up in the neighborhood with no places to play. Questioned what consideration has been given about the upbringing of children in the plans.*

*Will Leaf, North State Street resident, spoke in support of the first three sections of the Comprehensive Plan but requested improvements to page 18, noting concern about how the housing burden is described.*

*Jeffrey Post, resident, requested outreach to realtors about the Comprehensive Plan, suggesting there is not yet awareness in this sector.*

*Jeff Crockett, 506 East Kingsley, requested the inclusion of historic districts in the "character areas" of the Comp Plan.*

*Mary Henderson, spoke in opposition to the Comprehensive Plan and encouraged participation in a petition to pause the plan effort.*

*Adam Jaskiewicz, 1430 Las Vegas Drive, spoke to the high cost of housing in Ann Arbor and asked for clarification on definition of commercial and further information on tax expenditures.*

*Brad Pritts, 3030 Lexington Drive, urged inclusion of UM plans in the Comprehensive Plan process and requested additional engagement to*

*match unique neighborhood needs.*

*Tom Stulberg, 1202 Traver Street, spoke in opposition to the draft Comprehensive Plan. More details are better for a Comp Plan, urging more specific content and less cartoons.*

*Eric Ivancich, Towner Boulevard, spoke in support of the Comprehensive Plan.*

*313 Braun Court Site Plan for Planning Commission Approval; SP24-0018 - A proposed seven-story building with 38 residential condominium units. Thirty-three parking spaces will be provided on site. Vehicle access to the site is proposed from the existing alley between Catherine Street and East Kingsley. The development would require demolition and removal of the current structures. The project is pursuing LEED silver certification. Zoned D2 Downtown Interface.*

Stated he was here to talk about parking, stating should use experience based model to forecast parking demand. Would like to see C2 removed, green space added, developer can come back with a revised plan in 2029 if more parking is necessary.*

*Kathleen Chow, 2907 Whittier Court, work in office building nearby and live closeby. Spoke in support of the proposed plan.*

*Eric Ivancich, resident, spoke about parking with the proposed project*

*Tom Stulberg, 1202 Traver Street, stated this is a good location for this type of development. Compared project to Lowertown raising concern about rent prices.*
