NEW BUSINESS

Presenters - Engineering Team N Hutchinson, C Wall and M McColula from Wade Trim.

Team in charge of building many of the City Capital Projects (roads, utilities, bridges, sidewalks, etc.) in the city. Discussion this evening on the project on start next year on Nixon Road Improvement Project between Huron Parkway near Dhu Varren Green intersection and that will flagged a s public art project and our next steps. Discussion of the Nixon Road project from Huron Parkway to Dhu Varren =/Green Road 0'8 miles. Residential area north 3 school Bound by 2 existing roundabouts (Dhu and Huron Parkway) is a growing corridor.

This is a complete Road Reconstruction with water Main & Stormwater Improvements. Roundabouts selected as preferred alternative from 2017 study to meet project goals:

- * Improved safety for pedestrians, bikers an drivers*
- * Increase non-motorized & traffic facilities*
- *Reduce user delays and improve access*

Schedule

- *Final Plans October 2024 -*
- *MDOT Bidding January 2025 -*
- *Construction Start Summer 2025 and*
- *Construction End in Fall of 2026*

Guidelines and Budget

- *Designed to withstand natural weather*
- * Foundation maybe necessary*
- *Must not obscure sightlines to road uses (Cars, bikes, peds)*
- *Must not be hazardous if struck by a vehicle or alter driver behavior*

Cost

- *\$55,200 proposed budget (total for phase 1 & 2)*

NEXT STEPS

Conform process - Create RFP - Setup Committee - Provide Regular Updates

Commissioner Feedback:

Thiefels shared ideas on working with other art ideas, i.e. murals, etc. Available for additional input and support as needed. Engineering team will begin RFP selection process soon.

Fuller suggest use city flag in one of these areas to make it Ann Arbor focused. Could be cost effective.

Grillet agrees with three-dimensional object; cost a concern. Look into cost of regional v local artist. Feelings and emotion would the commission like to see and this will help us tailor the design - their neighborhood and things that residents give it character - leaving and going in and out welcome people welcoming people to the city.

Marietta identify as a neighborhood and give ownership and pride - say something good about the neighborhood - value that we hold and people look to this.

Set maintenance i.e. lawn, trash, etc, responsibilities.
