CIP Work Group

- Updating CIP list for 2020, identifying any new or ongoing projects that might include public art enhancements

Special Projects Work Group (formerly City Hall Gallery Work Group)

- Facilitating and strengthening the partnership between the City Hall Gallery and the Ann Arbor Art Center
- Facilitating the re-consideration of other City Hall spaces for inclusion and enhancement
- Support the design of a new “I Voted” sticker for the 2020 election cycle, in collaboration with the City Clerk’s Office

Communications and Public Outreach Work Group

- Strengthening the working relationship with the City’s communication department.
