**A motion was made by Commissioner Armstrong and seconded by Commissioner Riggs to recommend City participation with Northfield Township in the acquisition of a conservation easement on the property identified in application ID 2023-01, approve a participation agreement with Northfield Township, and appropriate funds, not to exceed \$50,400.00, from the Open Space and Parkland Preservation Millage proceeds.
