##### **Distribution of Marijuana Excise Tax**

*L. Jackson discussed the Marijuana Fund Appropriation Tax and the Resolution ( R 21-098) that City Council passed March 15, 2021. She urged these funds should be used to help a population that was most affected by the war on drugs and help at-risk youth. Deputy City Attorney, Arianne Slay updated the commissioners on the Expungment and Diversion programs. F. Todoro-Hargreaves suggest for public safety and community support the city need to take a closer look at emergency response for mental health and substance abuse.*

##### **Request For Proposal for Community Engagement Services (RFP)**

*L. Jackson discussed the Request for Proposal for Community Engagement Services. Reaching for a broader community outreach to ask the citizens what they might want in a response program and their thoughts on how the money is spent? She ask how does the city reach people who will be most impacted; the disengaged and disenfranchised from the political process? The applications for the RFP has been narrowed down to two, who will run the outreach in Ann Arbor.*
