Hi Councilmember Ghazi Edwin,

I called and left a voicemail earlier asking for you to support a ceasefire resolution, as a Jewish, anti-Zionist constituent of Ward 3. I have been watching the meeting online and I am sad that it seems (at this point in the meeting, anyway) that Ann Arbor is choosing not to take up a statement of solidarity with Palestinian citizens, but I want to offer compassion and just really try to bridge a gap here. I understand the desire to bring people together. I do not believe these are mutually exclusive goals. We can call for a ceasefire while also holding compassion for the grief people are experiencing. In fact, I believe we cannot bring this conflict to a close without all of us coming together and calling for an end to the killing of Palestinians in Gaza and Palestine as a whole.

I can speak only of my experience as someone who has organized for a free Palestine here and elsewhere in the United States, but, in Ann Arbor, I have faced far more hatred and vitriol from people within my own religion than those outside of it. I've been called a fake Jew, a self-hating Jew, seen friends be assaulted, called a terrorist supporter, and more. I have faced far more kindness from Palestinians, including survivors of massacres in occupied Palestine (who I would fully accept being cautious around me), and have rarely felt unsafe. I will acknowledge that this time has felt different and more threatening than much of my previous advocacy work, but I think much of that is because many people engaging in these discussions were not previously engaging with what has been going on and who, in the absence of credible sources, are following emotion and believing conspiracies. Yes, there has been an increase in antisemitism, but anti-Zionism is not antisemitism. The equating of the two, is, I think, furthering the anger at us as Jews in a way that acknowledging that what is happening is an undeniable atrocity would not, because it makes people believe that we as Jews are inherently responsible, not that the Israeli government (which does not represent all Jews, especially those of us living in diaspora) is responsible for its actions. It also erases the many Jewish voices speaking truth to this, including my own. Pulling out protest signs I made years ago during previous acts of aggression, such as one I made only a couple of years ago during the evictions in Sheikh Jarrah, has been devastating, but I am strengthened by the many strong Jewish voices calling for an end to the occupation both now and in the past.

I would like to share with you the words I have returned to many times since October 7th, from a Yiddish email list, Yidishistn mit Palestine:

To honor all the dead we must stop this next catastrophe. We must struggle alongside Palestinians for their liberation and to end apartheid. We write in Yiddish because we believe in the thriving of a Jewish diaspora free from zionism and all other state nationalisms. Enabling the destruction of Gaza is not a way to grieve. We must interrupt genocide. We must do this together.

I could only find a PDF version of the ordinance, so I couldn't create a redline version myself, but I think my proposed amendments will be relatively clear. I wanted to provide them to you for review before submitting them. Please feel free to call me tomorrow (Monday), as necessary.

#### AMENDMENT 1

6:702. – Regulation of Gas-powered Leaf Blowers.

(1) Summer ban and phase out. Beginning on June 1, 2025, the use of Gas-powered Leaf Blowers is prohibited in the City from June 1 to September 30. Electric Leaf Blowers may be used during this time.

(2) Seasonal use and phase-out. The use of Gas-Powered Leaf Blowers is permitted from October 1 to May 30 through the year 2027. Beginning January 1, 2028 the use of Gas-Powered Leaf Blowers is



prohibited at all times in the City.

#### AMENDMENT 2

6:703. – Regulation of Leaf Blowers Generally.

~~(1) Hours of operation. Leaf Blowers may only be used during the following hours:~~

~~a. Monday through Friday 8 a.m. to 6 p.m.~~

~~b. Saturday and Sunday 10 a.m. to 5 p.m.~~

~~(2)~~ (1) Blowing off-property prohibited. It is prohibited to blow or sweep debris, trash, leaves, plant clippings, or yard waste into a neighboring property, street, sidewalk, drain, or public right-of-way.
