And on the weekend, when the office is closed during the day and security is not scheduled to come till later: well, with the door now broken, criminals and whoever else wants to enter can simply walk in, at their leisure.

With the 4th of July holiday approaching, many residents are fearful of what might happen with very limited security presence, and a home that is completely open to the outside world.
