1. Raymond Somich - Zoning Amendment (DC-3) (Zoom)

Raymond Somich, Ohio resident, stated he has been unable to open his Cannabis business due to an oversight in the City's Zoning Ordinance that he wasn't alerted to prior to buying a business and leasing a space. He urged support of Item DC-3 to start the process of fixing this error.
