My tenants pay **LESS** THAN HALF of what this one will be charging. A huge factor in being able to do that is by staying 100% occupied.

Not being able to show our apartments to students in need of relatively affordable housing at a time that is flexible to them, and on the same availability scale as UofM and these luxury student housing complexes, hurts students.

Please consider this when making a decision about this ordinance.

Hello Mayor Taylor and Council Members:

I was very disappointed to see that the first reading of this ordinance was passed - even with the removal of the eviction amendment.

I would like at least one member to email me or call me at [REDACTED] to explain to me who this amended ordinance is helping. So far, I have not heard from anyone.

I do not see how this amendment helps the general student - especially those with limited means who **need** "affordable housing" and need to know what their costs will be far in advance - or the small-time property owners.

When I get calls in September, October, early-November asking about vacancies, I explain the 70 day ordinance. I explain how it is respectful to the current student-residents, and let the caller know that I will contact them in just a few weeks. Some understand, while others go on to contact other apartment managers who use "work-arounds" or who regularly carry empty rooms and apartments that can be shown.

If this amended ordinance passes, when I get a call in September, October, or early-November, instead of explaining the ordinance and why waiting just a few weeks is good for everyone, I will have to tell them that we have a city ordinance that prevents us from asking about availability until **April**. And let them know that I will not even be able to show them an apartment until April.

Even though, by this point, the current residents will have had more than enough time to know if the apartment meets their needs. And even though students returning to school the following year, know what their plans are.

This will force these pro-active students who are seeking housing to go to the big apartment companies and high-rises where empty apartments and rooms are available to show.

These complexes will have leases to be signed, even though the students will not even know which EXACT apartment they will be getting.

This new lease signing ordinance clearly seems like a way to direct students away from small business owners to larger corporate complexes who generally charge more money.

I wonder how these students will feel when my reasonably priced apartments come on the market after they have signed expensive leases because that is all the city allowed to be available to them.

I must be misunderstanding. If someone could respond by email or give me a call to explain, I would appreciate it.

Mayor Taylor and Council Members:

While I appreciate all that you do and your efforts in always working toward making Ann Arbor a better city in so many ways, I am disappointed to see that you are moving forward with an ordinance that does not take students or small business owners welfare into consideration. I am having a really hard time understanding the impetus for this change.

I am a local property manager with many, many years experience in the Ann Arbor rental world - **both as a renter growing up here, and currently as a manager of a small apartment building owned by an older retiree.**

When I first began managing the apartment building, and all the way up to today, as I am sure that you have heard from others, I have students contacting me before I even begin to market my available apartments. I am very respectful and protective of my tenants. I am sure if you asked any of them that they would concur. So, right from the beginning I have to explain to them the ordinance that the city has regarding not being able to show them the apartments as early as they would like. I do explain why it is in place and why it is respectful to the current residents.

The potential renters that have friends in my apartments feel lucky, because they have already been able to see them and will have an application all ready filled out and ready to give to me in the event that there is availability. **But others who would like to lock down an apartment just as early, but who can't have the same kind of viewing access, I often lose to those large apartment buildings with vacancies, or, to those places that have informal "work arounds" in place.**

I say all of this to point out that wanting to pin down plans early for the following year is student driven. These are successful, smart, engaged young adults who are used to being pro-active and planning well in advance. **It helps them feel more ready and stabilized for the upcoming year having such a major component already taken care of. THEY tell me that having their housing needs in place early allow them to move forward more confidently with all of their other plans.**

There are those times that a resident just does not know yet what they are doing the following year and must weigh out the situation and make calculated risks / choices. Like all of us, they do the best that they can in predicting what they will need in the future and they consider different contingencies for a possible change of plans.

Newer high rises and bigger businesses have empty, model apartments that they can show, or they rent by the room and have more vacancies. For them, renting to students is a "numbers game". This allows them to show units anytime despite any ordinance. **This is unfair to those of us who have unique, one of a kind, units and/or who don't have models or vacant rooms. Many rental owners in Ann Arbor are essentially small business owners. It is these small business owners that do not have empty models to rely upon that are most hurt by this kind of ordinance**

**(besides the students, themselves). In particular, small business owners who not only follow the letter of the ordinance, but also the intent of the ordinance.**

I have already watched the owner of the apartment building that I manage be hurt, as those who are trying to get settled and make plans early go elsewhere when I explain to them that we follow the city's ordinance which requires them to wait.

**Oftentimes, these are the students with less money who are working hard to secure a place that is within their means and will be safe for them. They prefer to know in advance that they will be able to afford everything, and not get stuck competing with everybody at the last minute. They NEED to know what their costs will be.**

**I believe this new ordinance will inadvertently hurt populations that I think you care about.**

I think it is very important for you to know these issues.

It will not affect those rental communities that have empty apartments to show, or the new high-rises with their multitude of rooms and models.

It will not affect those property owners that employ "work arounds", such as having interested parties knock on doors of current residents to have them show their apartments to those who are trying to pin down their living arrangements.

**It will hurt those small business owners that follow the ordinance and that respect their tenants.**

**It will hurt those students who are in need of knowing in advance that they have secured a more affordable housing option.**

For those students that do not want to plan in advance, there are still plenty of rooming opportunities the following fall. The number of beds that have increased in the last few years has been incredibly extensive.

I am writing to you all to ask that the proposed amendments to the Lease Signing Ordinance **not** be adopted.

**I think the overall harm will be felt most by concerned property owners and the most vulnerable and/or pro-active renters.**

**I hope you will take these concerns seriously and understand who the proposed changes would most hurt.**

I welcome more conversation on this issue. Please do not hesitate to call me if I can offer any further insight.

These amendments recognize that some home occupations might appropriately be practiced outside (such as a 4-person yoga class in your backyard, or bicycle repair in your driveway).

**Home Occupation Performance Standards (b):** (The following changes would enable home occupations to be conducted outside, without permitting outdoor storage)

Replace: ~~The use shall be conducted entirely within the interior of a Building, including all storage of goods, materials, and equipment.~~

With: Any storage of goods, materials, and equipment shall be entirely within the interior of a Building.

**Home Occupation Performance Standards (h):** (This change would rely on the City’s existing noise ordinance, not creating a new standard, while maintain some other restrictions)

Modify: No generation of dust, odors, ~~noise~~, vibration, or electrical interference or fluctuation shall be perceptible beyond the property line.

Note: Home Occupation Performance Standards (g) would still prohibit the outdoor use of mechanized equipment.
