Planning Manager, Brett Lenart, presented the upcoming Public Hearings at the October 17, 2023 Planning Commission meeting.

- 3874 Research Park Drive Site Plan for City Council Approval - A proposal to construct a 110,800-square foot office/research/lab space as Phase II of this project for a new overall total of 241,100-square feet. A new 77-space parking lot is also proposed on this RE (Research District) and ORL (Office/Research/Limited Industrial District) zoned site totaling 16.9 acres.

- 2929 Plymouth Road Site Plan for City Planning Commission Approval – University of Michigan Credit Union is requesting demolition of the existing office building and constructing a one-story, 4,740-square foot building on this O (Office) zoned site. This 1.73-acre site is proposed to be split with the western lot to remain vacant. Access is proposed off Plymouth Road and Prairie Street, accessing 22 parking spaces.

Addresses include 2929 and 2935 Plymouth Road.

[23-1638](#)** 900 Briarwood Circle Site Plan and Rezoning for City Council Approval - Developer proposes to replace the existing Sears store with a two-level grocery (57,649 sq. ft.) and a two-level sporting goods store (100,000 sq. ft.) with an adjacent playing field. The proposal also includes 354 multi-family residential units in four-story buildings, a parking garage, and redesigned parking with added landscaping. A new connector roadway will intersect with Briarwood Circle, east of Mall Drive. The 18.2-acre site will undergo rezoning from P - Parking District to C2B - Commercial, affecting 8.29 acres. Staff Recommendation: Approval.
