COMPREHENSIVE PLAN

Determine **VISION AND PRIORITIES** for the future of the city

Determine future land use, desired policy changes, and priorities for public spending and capital projects

DOWNTOWN AREA CIRCULATION

Identify **FUTURE CAPITAL IMPROVEMENTS** to downtown area streets and transportation plan updates

Balance the demands on limited downtown area street space

DDA DEVELOPMENT + TIF PLAN

Guide the DDA's **PROGRAM AND CAPITAL PROJECTS** for a 30-year time frame.

DISCUSSION OUTCOME/NOTES: 08/21 BOARD SESSION

Feedback on City Comp Plan Values:

- Advocate for added Comp Plan Value, unsure about the term vibrancy.
- “Active” (ok with using “density”): this needs to be really tight and not open to interpretation; people-focused; “livable”?? Spur more development.
- Liked “community” as a word

Feedback on DDA Goals:

- Incorporate housing more specifically (Improve foot traffic? More people?). May extend beyond A2 Housing Commission support to market-rate housing also.
- A 24-Hour Neighborhood with a Full Spectrum of Housing Options in the Downtown
- Add something on infrastructure? With housing as a sub-goal? Or retool one?
- Calling out energy but what about other resilient/ sustainable factors?
- Responsible design & implementation: Is this needed or implied w/ all work? Part of transparency, implementation, collaboration narrative.
- Event programming? Stay focused on DDA infrastructure role and support events through infrastructure (e.g., barricades, power).
- Need to connect to river & new river development.

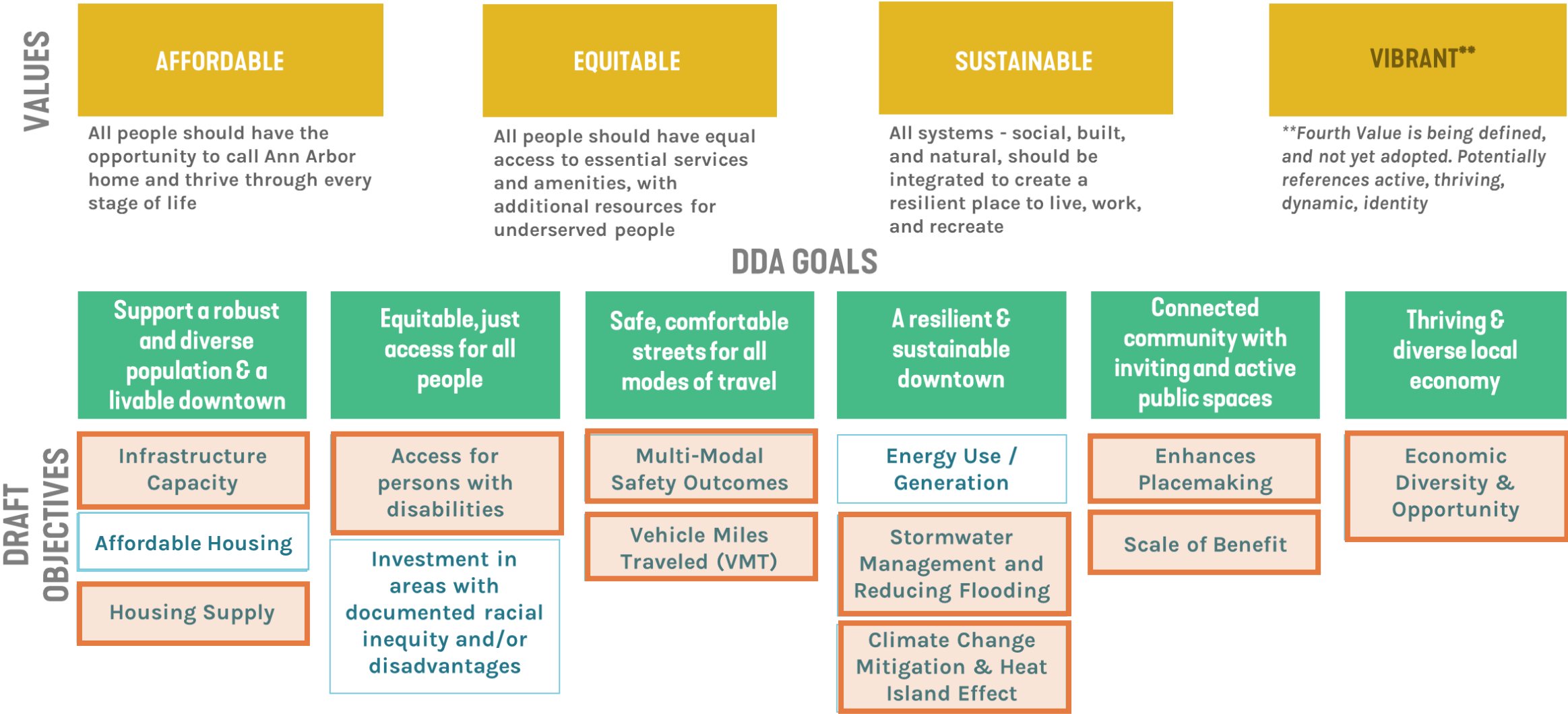

EXAMPLES – PROJECTS AND PROGRAMS

VALUE ALIGNMENT EXAMPLE: FIRST/ASHLEY PROJECT

PROJECT HIGHLIGHTS:

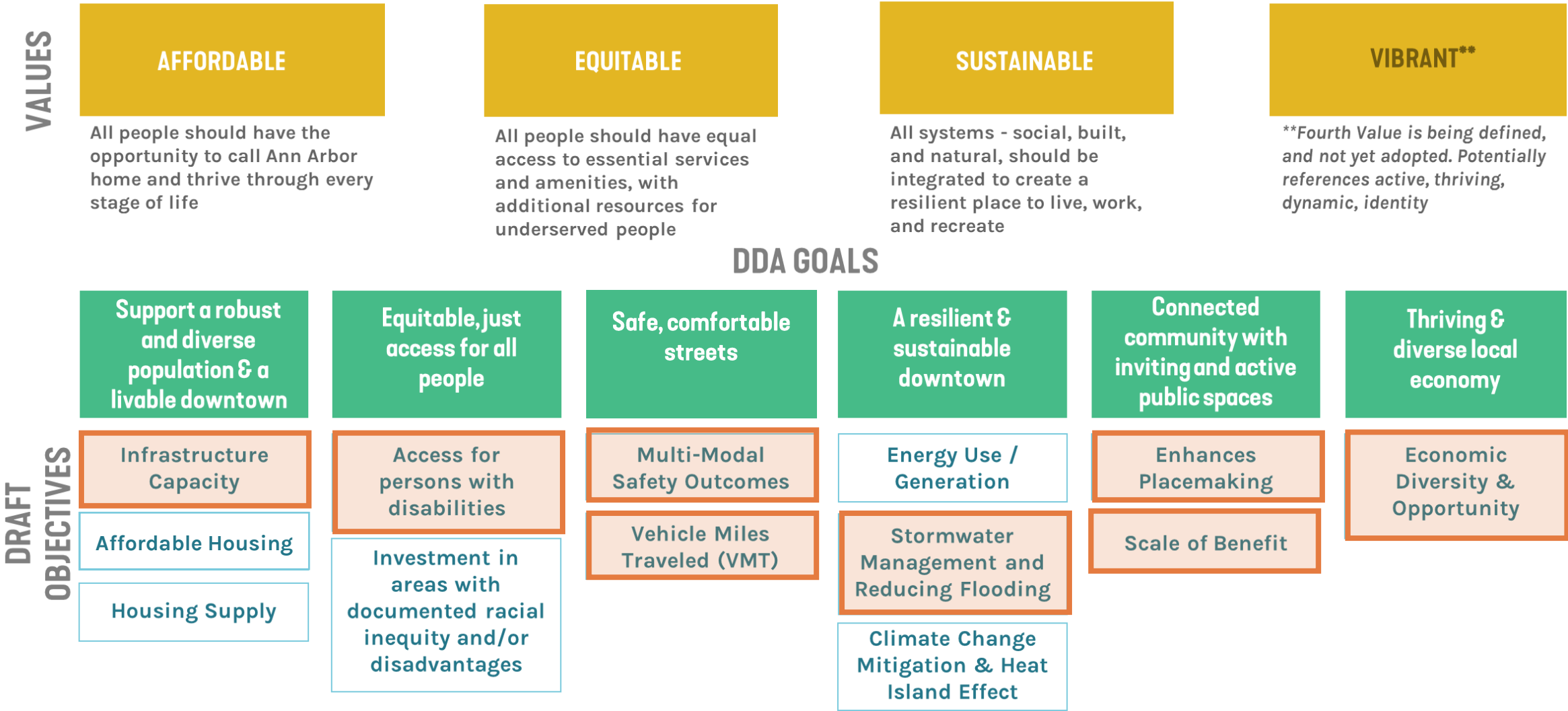
- Restored road to two-way travel, improving safety for all users
- Built part of the downtown bikeway loop, expanding mobility options
- Expanded sidewalk space and plaza areas
- Supported business activity through improved navigation and increased activity downtown
- Upsized watermain to support future development (DDA TIF-funded)



VALUE ALIGNMENT EXAMPLE: STATE STREET PROJECT

PROJECT HIGHLIGHTS:

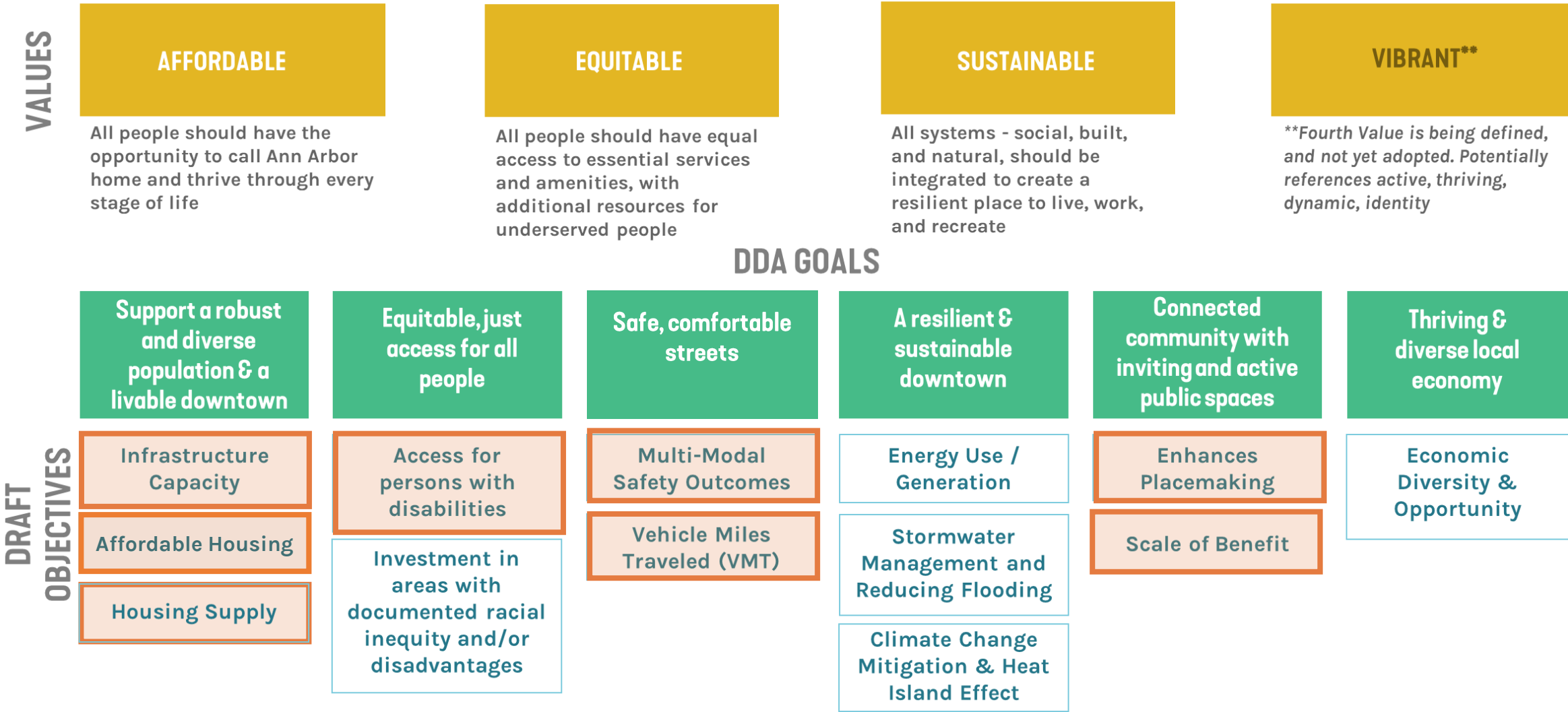
- Curbless design slowed streets, improved safety, and access for all people – no curbing reduced barriers to using the street
- Addressed flooding issues and improved stormwater management
- Equally expanded sidewalk space for businesses on both sides of the corridor
- Replaced and consolidated watermain (City Water and U-M funded)



VALUE ALIGNMENT EXAMPLE: FOURTH AVE TRANSIT STREET

PROJECT HIGHLIGHTS:

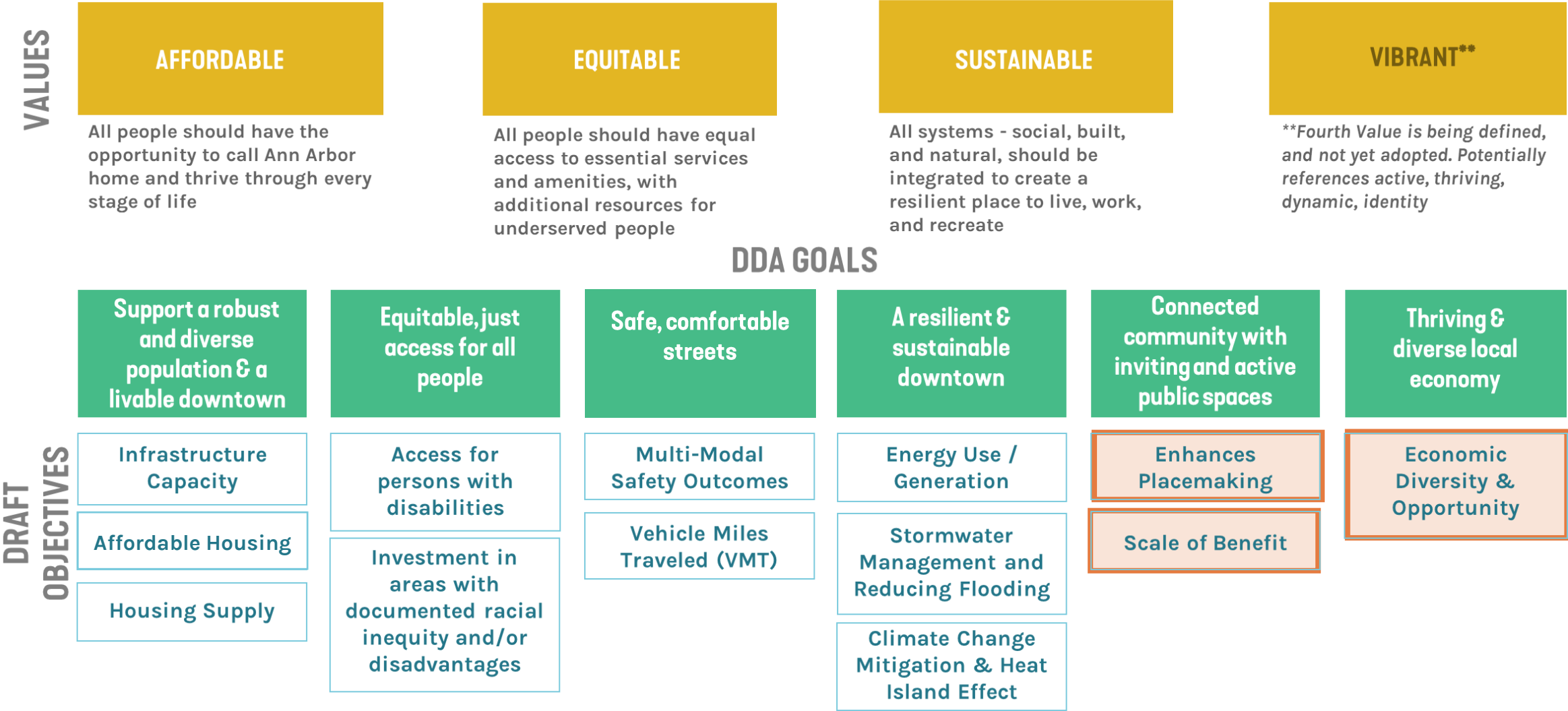
- Improves safety, comfort, inclusivity of using transit
- Transit use encourages other modes of travel and reduces VMT
- Project supports aligns with adjacent affordable and market rate housing investment



VALUE ALIGNMENT EXAMPLE: DDA ELEVATE PROGRAM

PROJECT HIGHLIGHTS:

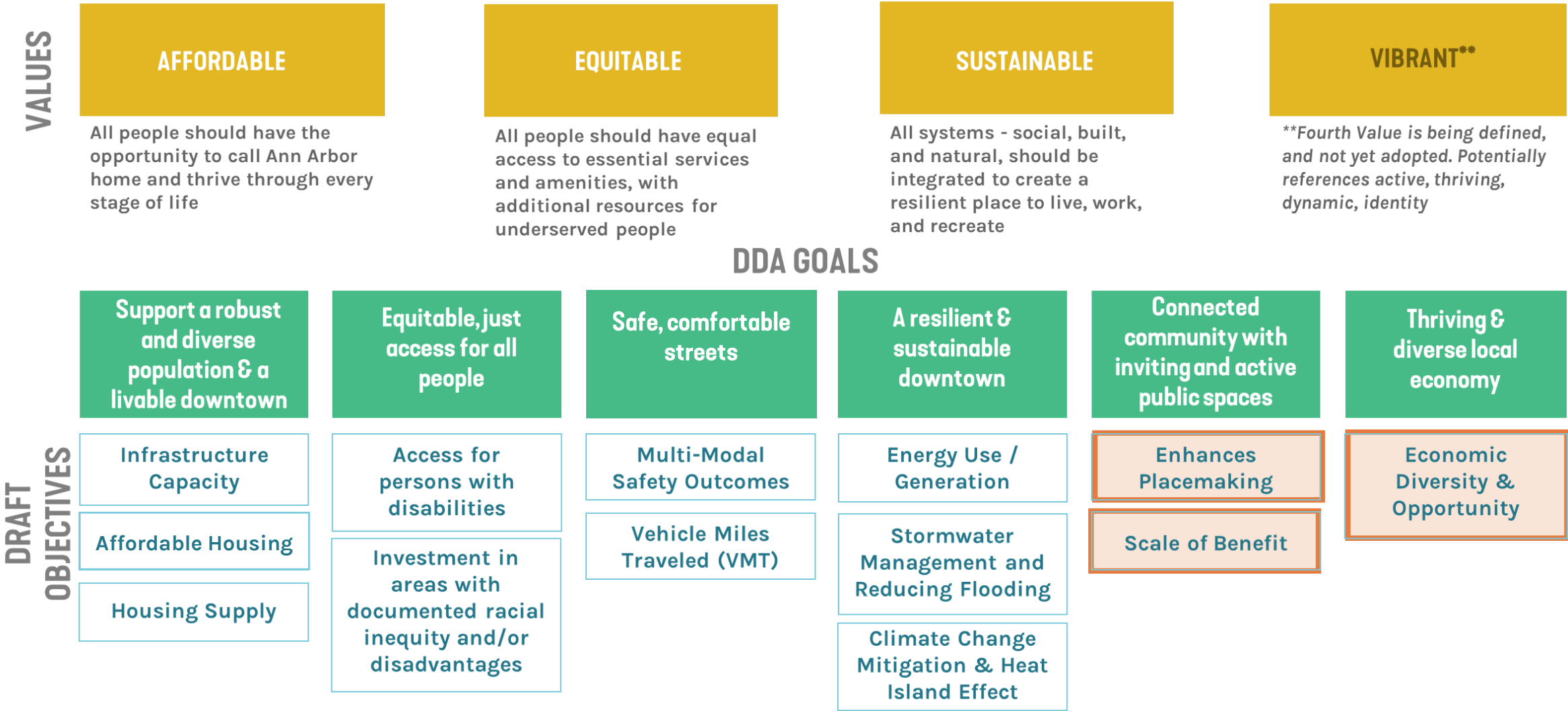
- Emphasizes placemaking and creating a vibrant, activated, dynamic downtown
- Builds on top of capital projects
- Promotes visitorship downtown and supports economic activity



VALUE ALIGNMENT EXAMPLE: DDA EXPANDED SERVICES

PROJECT HIGHLIGHTS:

- Includes: ambassador program, expanded maintenance services, event support
- Improves the quality of the downtown environment, sense of care, vibrancy
- Supports placemaking efforts, business activity
