Thank you so much, Courtney Manor. Could you please share with the Planning Commission this note as well, including the following exact quotation? I transcribed it from the CTN video of the July 1, 2025 Planning Commission meeting. Here it is:

"The majority of the people who created the Pause the Plan are older, are white, and aren't representative of the diversity, age, and where we are going in this town. Many of them bought in when housing was far more affordable, when life was far more affordable, and can't fully comprehend how difficult it is to afford a life here in Ann Arbor."

Astonishingly prejudiced! EACH HUMAN BEING AND EACH ETHNIC, RACIAL, OR NATIONAL GROUP IS DIVERSE FROM EVERY OTHER. We are all diverse. I'm mostly Swedish. That makes me diverse from people whose ancestors came from Burkina Faso.

Furthermore, some of us old folks have found living in Ann Arbor massively expensive. That's one of the reasons why I left.

And don't tell people they "can't fully comprehend" something. Another insult! Old, therefore stupid; white, therefore bigoted.

Absolutely astonishing. And, again, very revealing of the commenter's own prejudice.

How awful to hear whiteness and old age spoken of with such scorn. I hope you agree.

I also noticed a recent map from the city with no "Build a lot!" or any other "Build" notices for Ann Arbor Hills, just as I predicted. Rich people remain safe and sovereign on their land.
