A Memorandum of Understanding (MOU) between Washtenaw County and City of Ann Arbor commencing on September 27, 2024 and continuing in perpetuity during the levying, collection, and distribution of any portion of Mental Health and Public Safety Millage (MHPS Millage), the Roads Millage, or any additional millages that are remitted to the City of Ann Arbor on behalf of the Washtenaw County Board of Commissioners.

Background

The Washtenaw County Board of Commissioners placed the MHPS Millage on the November 2017 ballot in the amount of 1.000 mill and the voters of Washtenaw County voted to support the millage.

The Roads Millage was placed before voters in 2016 in the amount of 0.5000 mills and the voters of Washtenaw County voted to support the millage; the millage was subsequently renewed in 2020 and 2024.

Declarations

The Washtenaw County Board of Commissioners has determined that it is in the best interest of the residents and taxpayers of the County to have detailed plans and reports of all millage dollars.

Expectations

Washtenaw County will continue to levy the fully authorized amount of the millage, subject to Headlee rollbacks and other limitations, for the duration of the current millage levy. Washtenaw County will publish the plans and reports described below on the County's Open Book webpage.

All Millages

City of Ann Arbor will make their plan and budget available on their website when it is made available to Washtenaw County.

Mental Health and Public Safety Millage and any future millages

City of Ann Arbor will prepare and publish a plan and budget for the upcoming calendar year which, at a minimum, include both a narrative of the programs and projects to be supported, and a line-item budget of the expected costs of the planned programs and projects. This plan will describe the use of all funds expected to be collected with the December tax bill, as well as any use of millage fund balance, for use during the following calendar year. The use of millage funds should be described separately from other funding sources. This plan will be made available to Washtenaw County no later than December 31 each year.

City of Ann Arbor will prepare and publish a report on the use of millage funds used during the prior calendar year which addresses the outcomes of the programs and projects included in the plan for that year, as well as the actual uses of funds on a line-item basis. Millage funds should be reported separately from other funding sources.

This report will be publicly available and shared with Washtenaw County no later than June 30 following the calendar year addressed in the plan.

Where possible, City of Ann Arbor will include signage for projects funded with millage proceeds containing the County seal and stating, "Project funded by Residents of Washtenaw County." Any signage using the County Seal must be approved by Washtenaw County prior to production and usage, in conformity with County policies and procedures.

Roads and Non-Motorized Millage

City of Ann Arbor will prepare and publish a Four-Year plan and budget which address, at a minimum, the following points: the amount of millage funds expected to be collected and available to the organization; the specific segments of road, street, or trail to be improved; the type of work to be performed on each segment; the amount of millage funds to be spent on each segment; and the total cost expected for work on each segment; when the segment is planned to be improved; and which segments will include non-motorized components and the nature of those non-motorized components. The Four-Year Plan and Budget should be organized by calendar year and should ideally be available before the vote of the public on the millage question, but no later than December 31 of the year prior to the start of the time period addressed in the plan. Organizations which have cause to change their plans should prepare and publish an updated version of the Four-Year Plan and Budget which describes the changes to the plan and the reason for the changes no later than December 31 prior to the year in which work is to occur.

City of Ann Arbor will prepare and publish a report on the use of millage funds used during the prior calendar year which addresses the outcomes of the programs and projects included in the plan for that year, as well as the actual uses of funds on a line-item basis. Millage funds should be reported separately from other funding sources. This report will be publicly available and shared with Washtenaw County no later than June 30 following the calendar year addressed in the plan.

Projects that are funded with proceeds from the Roads and Non-Motorized Millage shall have signage containing the County seal stating, "Project funded by Residents of Washtenaw County." Signage must be visible in all traffic directions.

Resolution to Approve a Memorandum of Understanding (MOU) between the City of Ann Arbor and Washtenaw County for Planning and Reporting of County Authorized Millages On May 1, 2024, the Washtenaw County Board of Commissioners unanimously adopted a resolution that established expectations regarding the planning and reporting of organizations that are responsible for administering Washtenaw County authorized millage funds and directed County Administration to pursue Memorandums of Understanding (MOU) with each organization regarding those expectations.

The City of Ann Arbor receives an allocation of funding from the Washtenaw County Roads and Non-Motorized Millage (Approx \$1,852,000.00 annually)(the "Road Millage") and the Mental Health and Public Safety Millage (Approx. \$3,200,000.00 annually) (the "Mental Health and Public Safety Millage"). The Road Millage funds are used to supplement the City's own road millage, used to resurface and reconstruct city streets. The County Mental Health and Public Safety Millage rebate funds are allocated based on City Council adopted resolution, #R-24-396. The funding is allocated as follows:

- 40% to support/create an Unarmed Response Program
- 40% to fund supportive services for residents of the Ann Arbor Housing Commission properties
- 20% to improved bicycle and pedestrian safety

The MOU intends to increase accountability and transparency related to the levied millage revenue by requiring the City to prepare and publish a four-year plan for use of the Road Millage revenue and a 1-year plan for the Mental Health and Public Safety Millage revenue, as well as an annual report for each levy. In addition, any projects funded by the Road Millage requires that signage be posted identify the project as millage funded. The MOU will apply to any additional millages that are remitted to the City from the County in the future as well.

WHEREAS, the Board of Commissioners has the sole authority to place countywide millages on the ballot to be considered by the voters of Washtenaw County; and

FOUR YEAR PLAN AND BUDGET: Each organization should prepare and publish a plan which addresses, at a minimum, the following points: the amount of millage funds expected to be collected and available to the organization; the specific segments of road, street, or trail to be improved; the type of work to be performed on each segment; the amount of millage funds to be spent on each segment; and the total cost expected for work on each segment; when the segment is planned to be improved; and which segments will include non-motorized components and the nature of those non-motorized components. The Four Year Plan and Budget should be organized by calendar year, and should ideally be available before the vote of the public on the millage question, but no later than December 31 of the year prior to the start of the time period addressed in the plan. Organizations which have cause to change their plans should prepare and publish an updated version of the Four Year Plan and Budget which describes the changes to the plan and the reason for the changes no later than December 31 prior to the year in which work is to occur.

points: the actual amount of millage funds collected and expended; the specific segments of road, street, or trail improved; the type of work performed on each segment; the amount of millage funds spent on each segment; the total cost of work on each segment; and which segments included non-motorized components and the nature of those non-motorized components. The report should be publicly published and shared with the Board of Commissioners no later than June 30 following the calendar year described in the report.

BE IT FURTHER RESOLVED that the Washtenaw County Board of Commissioners hereby establishes the following planning and reporting expectations for all organizations with decision making authority which administer funds received through the extra voted millages of Washtenaw County, including Parks, Natural Area Preservation, Enhanced Emergency Communications System, Veterans, Mental Health and Public Safety, and Conservation District, and any future extra voted millage to be approved by the voters of Washtenaw County:

- 1. ANNUAL PLAN AND BUDGET: Each organization should prepare and publish a plan for the upcoming calendar year which, at a minimum, includes both a narrative of the programs and projects to be supported, and a line-item budget of the expected costs of the planned programs and projects. This plan should describe the use of all funds collected with the December tax bill, as well as any use of millage fund balance, for use during the following calendar year, and millage funds should be described separately from other funding sources. This plan should be publicly available and shared with the Board of Commissioners, and should ideally be available before the vote of the public on the millage question, but no later than December 31 of the year prior to the start of the time period addressed in the plan.
- 2. ANNUAL REPORT: Each organization should prepare and publish a report on the use of millage funds used during the prior calendar year which addresses the outcomes of the programs and projects included in the plan for that year, as well as the actual uses of funds on a line-item basis, and millage funds should be reported separately from other funding sources. This report should be publicly available and shared with the Board of Commissioners no later than June 30 following the calendar year addressed in the plan.

BE IT FURTHER RESOLVED that the Washtenaw County Board of Commissioners hereby directs the County Administrator to pursue Memorandums of Understanding (MOU) with the outside agencies that directly or on a pass-through basis receive funding from countywide millages, and that the content of the MOU align with the expectations established through this resolution regarding both the Plan and Budget, the Annual Report, the presentation of information to the public, and any additional resolution language from individual Board of Commissioner approved millage resolutions.

BE IT FURTHER RESOLVED that MOU developed for organizations receiving funding through the Roads and Non-Motorized Millage also include that signage must be posted along millage funded segments which states "Project funded by Residents of Washtenaw County", and that the signage contain the county seal and be visible in all traffic directions.

BE IT FURTHER RESOLVED that the Washtenaw County Board of Commissioners hereby directs the County Administrator to post all Annual Plans and Budgets, Annual Reports, and other documents prepared and received as a result of this resolution to the County's Open Book web page.
