Moved by Commissioner Wyche seconded by Commissioner Mills that:

The Ann Arbor City Planning Commission, after hearing all interested persons and reviewing all relevant information, including an accompanying site plan, finds the petition substantially meets the standards in Chapter 55 (Unified Development Code), Section 5.29.5.D (Special Exception Use) and Section 5.16.1.E (Fraternity, Sorority, and Student Cooperative), and therefore approves the 700 South State Special Exception Use for a Fraternity, Sorority or Cooperative Housing at 700 South State Street. This approval is based on the following findings:

- 1. The proposed use will be consistent with the R2B (Two-Family Dwelling) District which allows single- and two-family residential uses and fraternities by special exception.**
- 2. The proposed use will not adversely impact traffic, pedestrians, bicyclists, circulation, or road intersections based on the location. South State Street and Monroe Street provide access to the site, and the proposed use is consistent with the existing and other surrounding uses' traffic impact.**
- 3. The subject site meets the use specific standard of at least 8,500 square feet of lot area and 350 square feet of lot area per occupant.**
- 4. A site plan documenting the existing and proposed conditions of the site has been submitted as part of this application.**

This Special Exception Use approval is based on the following conditions:

- 1. Occupancy is limited to 28 people.**
- 2. A resident manager will live in the building.**

3. Trash, recycling, and bicycle parking improvements shown on the site plan will be installed by March 4, 2025 and the Public Services Division may require a completion bond. And that the Ann Arbor Planning Commission approves the attached Site Plan dated 8/21/2024 which demonstrates compliance with the applicable Special Exception Use standards as no development which would otherwise require site plan approval has been proposed.

The Commission took into consideration the proposed request and discussed the matter. [For a complete record of the discussion, please see available video format.]
