

I currently rent a Village Green property at Mill Creek Townhomes and also receive an MSHDA voucher.

I am the head of my household and am currently earning an MSW at Wayne State University.

While I am awaiting my placement for a practicum this fall, I am currently between jobs and have a much lower income than I was earning after earning my bachelor's degree as a non-traditional student at EMU in 2018 (annual salary of \$58K). Consequently, my rent with the MSHDA Voucher is adjusted to reflect my lower-than-average income, at this time, while I continue my studies and hunt for work commensurate with my experience and skills.

After investigating the water usage calculations illustrated through <u>the city of Ann Arbor's Water</u> <u>department site</u>, and asking the people working in the city hall building if I am being overcharged for water, along with hearing from several homeowners in the surrounding area, I believe I am being overcharged for water, especially while my oldest daughter is primarily living in a sorority house on campus, and our water usage has dropped significantly in the recent months. Please advise, after looking at the monthly rate my household is being charged for water (attached pdf), if you would advise me <u>to file a formal complaint through the Renter's Commission site</u>, or which avenue a lower income family like mine can stop being overcharged for water?
