*Staff could offer updates or direction as the Comprehensive Land Use Plan proceeds to City Council.*

*Deputy Planning Manager Kelley noted Staff is aware of these bills noting the Michigan Association of Planning sent an email alerting members, Staff sent a team email making them aware and we could discuss at a future Staff meeting. Deputy Planning Manager Kelley also noted we would be happy to expand awareness by collecting and sharing information.*

*Chair Wyche noted he has an article that reviews all the bills and includes links and that he will forward to Deputy Planning Manager Kelley.*

*Deputy Planning Manager Kelley stated that Planning Commission may add time to a future agenda if discussion is desired and suggested that City Council would be the most appropriate body to send communication of support (or otherwise) to the State House of Representatives regarding the bills.*

*Commissioner Adams noted that, for the staff meeting, consideration should be given to how preemption could affect local regulations and rather than replacing existing setback numbers, it could eliminate local standards altogether. He suggested having a prepared approach in place to address this possibility.*
