RESOLUTION REGARDING THE ANN ARBOR HOSPITALITY COMMITTEE

RESOLVED, that the Ann Arbor City Council hereby create the Ann Arbor Hospitality Committee, to be composed of members of the community, including representation from the University of Michigan, the Multi-Ethnic Alliance, the Chamber of Commerce, the Conference and Visitors Bureau, Business, the Arts and interested citizens. Among the possible directions this committee may take are:

- 1) Exploration and development of our Sister City commitments (student exchanges, charter flights, artistic programs, etc.). There shall be one subcommittee for each Sister City, chaired by a member of the Ann Arbor Hospitality Committee.
- 2) Establishment of an ongoing relationship with appropriate U-M hospitality groups, the Chamber, the Conference and Visitors Bureau so as to utilize, without duplicating, all available resources.
- 3) Work toward the installation of a permanent Visitors Center in the downtown area, available 24-hours a day, with a terminal utilizing the Campus Information Center's computer. This center would also have ticket sales capability for events in the city.
- 4) Development of a permanent "hot-line" which would provide the visitor with information in a number of languages.
- 5) Completion of an information packet on the city which could include maps on major streets and shopping areas, historic walking tours, bicycle paths and

rental information, parks and recreational opportunities, special interests (antiques, art galleries, books and records), restaurants by location, specialty, and price.

- 6) Investigation of possibility of creating a bed-and-breakfast network along the English model.
- 7) Development of a list of appropriate gifts representing Ann Arbor and/or the state. This might motivate local artists to create souvenir plates, glassware, mugs, books, crafts of all kinds and prices.
- 8) Service as a community resource upon which Ann Arbor residents and the public schools can draw for information on cultures of other countries.
- 9) Search for funding of its activities within the private sector. However, recognizing that the Ann Arbor Hospitality represents the residents of Ann Arbor, City Council will also consider appropriate funding requests in the future.

Whereas, Money to pay this fee would be lost to the rape victims assistance fund, which supports women who have been raped and who need help paying medical expenses;
