*Ann Arbor Police Chief Jim Baird will be coming to the June Commission meeting to present the status of the Disability Awareness Training within the department. He will also be providing an update on the distribution of the Disability Awareness Cards.*

**2. Update on Ann Arbor Inclusive**

*Z. Damon reported that the show has been moving forward quite well. Austin Sheperd was just a guest, from the WISD LEO club and John Krinke who is the head of the Ann Arbor Lions Club was also there. Z. Damon is still committed to pushing closed captioning for this show.*

**d Partners in Access Committee - West Resendes and Alison Stroud**

*A. Stroud mentioned that next PIA meeting is at 6:00 pm on May 23 in Basement Conference Room of City Hall. A presenter, Matt Finnigan, will be there to give information about accessibility of crosswalks.*

*The letter to the AAATA was successful, and a few board members are very interested to talk to the Commission about best practices. The meeting with the board members will hopefully be discussed at the next commission meeting.*

*W. Resendes gave an update on the Closed Captioning Ordinance. He was invited to attend the Cable Commission meeting two weeks ago, so they could learn more about the Closed Captioning Ordinance. He was checking their budget for Closed Captioning, and he shared that there will be captioning starting at City Council meetings starting this Fall. He has asked for opinions on other boards or commissions of the City that should be closed captioned so he can report back to the Cable Commission. Z. Damon recommended that all city broadcasts should be captioned. He would like to discuss further with W. Resendes about captioning more programs - especially the Ann Arbor Inclusive show. The Cable Commission supported the Ordinance.*

*K. Westphal spoke with Chris Frost in the City Attorney's office, who believes that a draft of the Ordinance will be sent to the Commission before the next meeting.*

**e Recruiting Activity - Larry Keeler**

*The Commission has a new member, Rebecca Benedict. It appears that there is another application being reviewed right now. Please contact the Commission or the Mayor's office for an application if you are interested in joining the Commission.*

*K. Westphal spoke with the Attorney's office and Sally Petersen about the bylaws of the Commission and the recruiting needs of the Commission. Z. Damon would like to present this issue to Sally to discuss with the Commission. L. Keeler would like to set a meeting up to discuss this with the Recruiting sub-committee.*

*A. Schnitzer would like to discuss the Air Ride Michigan Flyer. It is an excellent and reasonable mode of transportation. Currently there is a "difference of opinion" between the Metro Airport and the Air Ride Michigan Flyer. She discussed her recent experiences with using the flyer system.*
