CHAPTER 95
(TEMPORARY REDUCTION OF DISTANCE REQUIREMENTS BETWEEN K-12
SCHOOLS AND MARIJUANA FACILITIES AND ESTABLISHMENTS)

AN ORDINANCE TO ADD CHAPTER 95 TO TITLE VII OF THE CODE OF THE CITY
OF ANN ARBOR WHICH SHALL BE ENTITLED "TEMPORARY REDUCTION OF
DISTANCE REQUIREMENTS BETWEEN K-12 SCHOOLS AND MARIJUANA
FACILITIES AND ESTABLISHMENTS"

The City of Ann Arbor ordains:

Section 1. That Chapter 95 be added to Title VII of the City's Municipal Code of
Ordinances which shall be entitled "TEMPORARY REDUCTION OF DISTANCE
REQUIREMENTS BETWEEN K-12 SCHOOLS AND MARIJUANA FACILITIES AND
ESTABLISHMENTS"

Section 2. That Sections 7:501 – 7:504 be added to Chapter 95 of Title VII to read as
follows:

Section 7:501 – Temporary Reduction of K-12 Distance Requirements

Notwithstanding the provisions of any other Chapter of the City Code of Ann Arbor, the
distance between marijuana facilities and establishments and a pre-existing public or
private school providing education in kindergarten or any of grades 1 through 12 shall
not be within:

- (1) 250 feet from 416 S. Ashley; or
- (2) 750 feet from 3980 Research Park.

Section 7:502 – Other Distance Requirements Remain in Effect

The distance requirements between marijuana facilities and establishments and any
other pre-existing public or private school providing education in kindergarten or any of
grades 1 through 12 shall remain in effect.

Section 7:503 – Sunset Provision

This Chapter shall sunset 1 year after its effective date.

Section 7:504 – Effective Date

This ordinance shall take effect 10 days after publication.
