Chair Keeler reported that he and Vice Chair Damon met with City staff to this week to discuss the concerns commissioners brought up at the last meeting. Chair Keeler shared that he and Chair Damon expressed to City staff that the commission desires monthly updates and communication on recent accessibility projects. Chair Keeler said he will receive a follow up from City staff soon. More information and details to come.

Chair Keeler shared that he and Commissioner Packard attended the Independent Community Police Oversight Commission (ICPOC) March meeting. This meeting featured a Community Conversation on Police–Community Interactions with special guest Dr. Nickolas Camp, a professor and researcher from the University of Michigan whose work examines disparities in police-citizen encounters and their impact on community trust. Chair Keeler reported that he shared his experience with police interaction and how police officers should have disability resources available on their patrol.

Commission Bylaws Discussion - LARRY KEELER

Chair Keeler asked commissioners last month to review the current commission bylaws. This is specifically in situations where the commission has elections and no Commissioner nominates themselves for either the Chair or Vice Chair position.
