AIRPORT MANAGER REPORT**C-1 Project Update - Environmental Assessment, Solar Array**

FAA Technical Operations has apparently completed their review of the Environmental Assessment. The FAA scheduled a conference call for late August to discuss the review and then cancelled the call which has not yet been rescheduled. The City continues to move forward with DTE regarding the installation of a solar array at the airport. Approvals by the City, Pittsfield Township and the FAA still must be sought and received prior to the project moving forward.

C-2 Other Items

Manager Kulhanek announced that the air traffic control tower will be hosting a runway safety action team meeting on October 7th from 1-3 pm in the basement conference room in the terminal building. The EAA has begun the renovation of the old hangar on State Road. New leases are being finalized for Bijan Air and the AvFuel Fuel Farm. We are still waiting on DTE to light the two utility poles along State Road to finalize the elimination of obstructions. Pittsfield Township is hosting meetings this week to discuss the sub-area plans as part of their Master Planning process. These two sub-areas include the State/Ellsworth area and the Ann Arbor Saline/I-94 area.

Member Garwood will be convening a meeting of the sub-committee in the near future to discuss the next steps.

E-2 Airport Long Term Planning Process

Chair Canter summarized the first work session meeting, which was held on September 3rd, to discuss the long term planning process at the airport. The next work session on this subject is scheduled for October 1st.

NEW BUSINESS

F-1 Airport Capital Improvement Plan 2015-2019

Manager Kulhanek reviewed the draft Airport Capital Improvement Plan (ACIP) that has been submitted to MDOT-Aero for consideration. MDOT-Aero has recently changed the process to a 5 year plan from the previous 10 year planning period. The level of planning for those 5 year projects is higher than in previous years. With the hiring of a new airport consulting firm this year, the consultant and Manager did a ground up review of proposed projects for costs, scope and needs. The airport

continues to follow a dual track approach to ACIP projects based on if the runway safety extension project goes forward or not. Each of the proposed projects was reviewed with the Committee. A motion to support the 2015-2019 ACIP as presented was made, seconded and unanimously approved.

Chair Canter requested that the unfinished items of business be continued on the next agenda.
