*Manhole Art Winners: Top three winners have been selected;

*Arbor Winds Replacement Glass: Funds are available to move forward with the replacement of the damaged glass panel. City staff working on the details of laser etching with a glazing company in Lansing.*

*Sidewalk Stamped Art: After review from the City Attorney, the consensus is that any non-uniformities on the surface of a sidewalk create potential maintenance issues and could possibly create trip hazards. At this time, it is not advisable to move this project forward.*
