SUBJECT: Ordinance Revisions related to Primary Use Permitted Zoning Districts for Child Care Centers and School, Private Uses

Introduction

Staff presents ordinance revisions related to the Zoning Districts in which Child Care Centers and Private Schools are allowed in Table 5.15-1. Per Section 5.30.5, a text amendment application was received (included in attachments) to allow Child Care Centers and Private Schools as permitted uses in the RE (Research) and M1/M1A (Limited Industrial/Limited Light Industrial) zoning districts. The proposed changes would allow Child Care Centers and Private Schools in RE (Research) and ORL (Office/Research/Light Industrial) districts as they are already allowed in some higher intensity districts. However, Private Schools are not proposed to be allowed in M1/M1A (Limited Industrial/Limited Light Industrial) due to their frequently large footprints given the small amount of M1/M1A (Limited Industrial/Limited Light Industrial) areas in the city.

Comments

- A text amendment application was received to allow Child Care Centers and Private Schools as permitted uses in the RE (Research) and M1/M1A (Limited Industrial/Limited Light Industrial) zoning districts. Currently, Child Care Centers are a Permitted Use in all M1 districts. The proposed change would allow Child Care Centers as a Permitted Use in the RE district and change them from a Special Exception Use to a Permitted Use in the ORL (Office/Research/Limited Light Industrial) district.
- 2. The proposed amendments would restore Child Care Centers and Private Schools as uses in the RE district, with Child Care Centers as a Permitted Use and Private Schools as a Special Exception Use. Chapter 55 in 2019 previously allowed Child Care Centers and Private Schools as Special Exception Uses in RE (Research) zoning districts.
- 3. The proposed changes also seek to align Child Care Center and Private School uses in the RE (Research) and ORL (Office/Research/Limited Light Industrial) districts.
