M. Lemieux gave the staff report. Recommend this application be denied as it does not meet the standards for approval, the code has not been misinterpreted, the provisions of the code do apply, and the current condition is less safe than the minimum requirements of section 1011.5.2 and section 1011.6 of the 2015 Michigan Building Code. The basis of this appeal suggests, what is proposed is equal or better than what the code requires but is not proven as such by the information provided in this appeal. Based on the requirements of the 2015 Michigan Building Code section 1011.5.2 staffrecommends the board deny this request and require new construction elements meet the minimum requirements of the 2015 Michigan Building Code as required by the 2015 Michigan Rehabilitation Code for Existing Buildings Section 801.3. The applicant states they cannot alter the structure because it is in the Historic district, but have not provided any information indicating that it is technically infeasible to reconfigure the interior to accommodate a code compliant stair geometry or a code compliant landing.

Following discussion between board members, applicant and city staff, B. Hart made a motion to table the appeal for 60 days while additional reviews take place between applicant and the city. Seconded by K. Cox. Motion carries unanimously.
