Resolution to Approve Professional Services Agreements with Fishbeck, Thompson, Carr & Huber, Inc. for \$500,000.00, Stantec Consulting Michigan Inc. for \$500,000.00, and Jacobs Consultants Inc. for \$500,000.00 for Water Treatment Professional Engineering Services (RFP #24-02) This memorandum and resolution requests approval of Professional Services Agreements for Professional Engineering Services with Fishbeck, Thompson, Carr & Huber, Inc. ("Fishbeck") for \$500,000.00, Stantec Consulting Michigan Inc. (Stantec) for \$500,000.00, and Jacobs Consultants Inc. (Jacobs) for \$500,000.00 for Fiscal Years FY25 through FY27 to be performed on an asneeded basis, with the option to extend the services for two (2) one-year periods.

The Water Treatment Services Unit (WTSU) is responsible for planning, budgeting, executing and managing design and construction on a wide array of capital improvement, operation and maintenance projects at the WTSU facilities. These facilities include the Water Treatment Plant, water storage and pumping facilities, as well as two recreational dams and 2 hydroelectric dams.

In January 2024, the City issued Request for Proposals (RFP) No. 24-02 for professional engineering services to supplement and support the WTSU with its significant workload and demands. The three engineering contracts will be used when additional support is needed to maintain the aggressive schedules and heavy workload associated with capital, operation, and maintenance projects, as well as to provide on-site and on-call engineering assistance for the Water System, dams, and hydroelectric facilities. Each of the contracts shall be structured with not -to-exceed limits of \$500,000.00 with no minimum required expenditures. Making use of these firms on an ongoing basis will permit the WTSU to more effectively utilize the existing workforce, while continuing to deliver quality and cost-effective engineering services to maintain the City's

water supply.

On February 20, 2024, the City received seven (7) proposals for this work. The RFP required each consultant to submit a statement of qualifications, work plan, fee schedule, and resumes of personnel that they proposed were qualified and available to work on WTSU projects. The WTSU Manager, Assistant Manager, and Senior Utilities Engineer reviewed the proposals and determined which firms were most quailed to perform the required services. The firms were evaluated and scored on the following criteria:

- Professional Qualifications (20%)
- Past Involvement with Similar Projects (30%)
- Proposed Work Plan (20%)
- Fee Proposal (30%)

After evaluation of the proposals and fee schedules, it was unanimously decided that Fishbeck, Stantec, and Jacobs provided the three best proposals and project teams at the most competitive price. It is therefore recommended that City Council approve the professional services agreement with Fishbeck, Stantec, and Jacobs to provide Professional Engineering Services for FY25, FY26, and FY27, with the option for two (2) one-year extensions.

All three firms comply with the requirements of the City's Non-Discrimination and Living Wage ordinances.

<u>Budget/Fiscal Impact</u>: These services are to be funded from the approved FY25 Water Supply System Fund, Park Maintenance and Capital Improvement Millage Fund, and the General Fund, Operations and Maintenance and Capital Budgets for which services are rendered. Funding for services rendered in future fiscal years will be included in those budgets if so, approved by Council.
