**F PRESENTATIONS**

**Side panels**

**Hillary Hanzel, Parks Planner, and Keith Kohler, architect from Kohler Designs, presented preliminary plan for roll up side panels. Design would provide roll down panels along main aisle and connect it to the office, with potential to expand to more stalls in the future. Heating was also considered, but would need solar panels and radiant heat installed, and could be done separately from roll down panels. Commissioners were largely in favor. Concerns were**

that it wouldn't cover enough vendors and some would be left out, and how heating would work if we didn't install the radiant heat. Next steps are to present design to vendors and get input, and get more info on budget, heating requirements, and cost of covering larger area.

Hemp & cbd requirements

Commissioners agreed to allow current vendors to bring legal hemp & cbd offerings to market, provided that they have the correct licensing. Products include: tinctures, salves, lotions, garments, but no smokeable flower. Market manager may open up to NEW vendor requests sometime in the future after this trial period.
