### 1. Staff Updates

*Ginny Trocchio said that she had hoped to receive information about their Federal Grants, but still have no word on the FRPP grants that were submitted in February for the properties in Webster and Northfield Townships. She did expect to hear something soon and would report back the findings at a later date. A resolution would then be forwarded to City Council for their consideration.*

*Ms. Trocchio said she participated in a discussion panel with the Michigan Organic Food and Farming Alliance which consists of a group of young farmers who were looking for land to farm and seemed very excited about the Greenbelt program.*

**REPORT FROM COMMITTEES**

*SMALL FARMS SUB-COMMITTEE*

*Commissioner Ezekiel said that the Small Farms Sub-Committee met March 4, 2010 and discussed easement language and how it would change in regards to small farmers while not having to worry about the Fed requirements. They also had a discussion about impervious surfaces and including a certain number of temporary impervious surfaces like hoop houses and what would be a reasonable percentage of hoop house properties to have in order to meet small farmers needs as well as the needs of Ann Arbor residents. They also talked about water needs and drainage. It was nice to have a variety of different stake holders there and it gave other people a chance to get familiarized with ideas that have been floating around regarding the Greenbelt's easement.*

*He added that Ann Arbor Township has been doing similar work and it was good to have a meeting of the minds to see what they were talking about and doing as well. They talked about whether having "farm police" or not and have very strict standards in the easement that are monitored closely or is it a more general idea and would there be a need for general reports. Everyone agreed that there needs to be a business plan going in.*

*The Sub-Committee also talked about purchasing development rights on a small parcel where there would be a small farm, the farm failing and what the disposition of the property would be afterwards. Affordable housing was discussed and a small farmer had an idea that he want to have housing where an apprentice farmers or beginner farmers could live and how that would look. A lot of progress was made, people had an opportunity to hear with other people were thinking about and how far they have gotten.*
