#### CALL TO ORDER

*L. Stambaugh called the meeting to order at 7:02 p.m*

#### APPROVAL OF AGENDA

#### INTERNAL BUSINESS

**Introduction: 1 Commissioner**

*L. Stambaugh welcomed Vanesa Jackson as a new commissioner on the Human Rights Commission. V. Jackson introduced herself to the commission and stated that she is excited to be a commissioner and looks forward to working on the commission.*

**Follow Up on Outside Group Work**

*City Council Updates - CM Ghazi Edwin & CM Song: CM Song reported that the City of Ann Arbor is still in the process of searching for and hiring a new Police Chief. Interim Police Chief Aimee Metzger will be retiring at the end of October and the new Interim Police Chief is Patrick Maguire. CM Ghazi Edwin announced that the City Attorney's Office will make recommendations about whether it would be advisable to extend the Ban the Box on employment applications policy to future city contractors. CM Song announced that City Council is working on zoning changes for housing in the City of Ann Arbor. CM Ghazi Edwin stated that Ann Arbor Housing Commission is potentially considering creating an affordable housing list for the City of Ann Arbor. More information and details are to come.*

*Facial Recognition - CM Song & A. Sova: CM Song reported that Interim Police Chief Aimee Metzger approved a contract with a software company called Truilo. Truilo uses artificial intelligence to review police camera footage. The police department has paused the deployment of the software and additional review has been requested by City Council. The facial-recognition ordinance ban is currently still being drafted.*

*Traffic Stop Ordinance/Public Forum - CM Song: CM Song stated that the Independent Police Oversight Commission had a Public Forum at the end of September. Community members came out to speak and address the commission regarding the recent traffic stop study report and the City's new Driving Equality Ordinance. *Housing Energy Rating Disclosure - CM Ghazi Edwin: CM Ghazi Edwin reported that the housing energy rating disclosure would require homeowners who are selling their home to have a City Assessor evaluate and score the home's energy efficiency. Equity concerns about the impact of this requirement have been raised. More details and information on how to track and report on the housing energy disclosure are currently being worked on.*

#### **Follow Up on Ongoing HRC Work**

*School of Social Work Partnership - L. Stambaugh: L. Stambaugh reported that the University of Michigan School of Social Work will have students conducting research on topics related to issues and challenges in the City of Ann Arbor. All research conducted by the students will be shared with the commission. Two groups out of the ten groups of students will present their research to the commission.*

*Human Rights Commission Mailing - L. Stambaugh: L. Stambaugh announced that the commission mailed out a newsletter last month to the commission's mailing list. The newsletter included notice of the new protection for government IDs added to the Non-Discrimination Ordinance, as well as notice of ICPOC's Public Forum.*

*Complaints – J. Garber & L. Winkler: There are three outstanding complaints in progress.*

*Trespass: Update – L. Winkler: The revised Trespass Notice is now being used by the AAPD. L. Winkler will follow up with the AAPD on how it is working and updates about it to the AAPD's policies and procedures.*

#### **OLD BUSINESS**

##### **Identifying LGBTQ+ Human Rights Needs**

*S. Peitzmeier reported that the discussion with the City Attorney's Office regarding the need for gender-neutral bathrooms is ongoing. (Research is being conducted by the City of Attorney's Office regarding proposed LGBTQ+ related ordinances that could potentially be passed in the City.)*

*State legislation is pending on this subject and the City has chosen to wait to see what it will cover, before deciding on any additional*

*recommendations. The commission will follow up with the City Attorney Office next month.*

#### **NEW BUSINESS**

*Drive Safe Michigan - CM Song: CM Song announced to the commission that State Senator Stephanie Chang is pushing the Drive Safe legislation. It would allow all Michigan residents, including DACA recipients, undocumented immigrants, and legal immigrants to be eligible to apply for driver's licenses.
