- The Detroit Edison Company proposes to issue a refund of \$24,975,000, plus interest to those electric customers who paid provisional rates in excess of final rates approved by the Michigan Public Service Commission, for the period July 26, 2009 to January 26, 2010.

PARTICIPATION: Any interested person may attend and participate. The hearing site is accessible, including handicapped parking. The Michigan Public Service Commission (Commission) will hold a public hearing to consider the April 1, 2010, application of The Detroit Edison Company (Detroit Edison) to refund \$24,975,000, plus interest, to its electric retail customers pursuant to MCL 460.6a(1) with respect to the provisional rates implemented by Detroit Edison during the period of July 26, 2009 to January 26, 2010.

All documents filed in this case shall be submitted electronically through the Commission's E-Dockets Website at: michigan.gov/mpscedockets. Requirements and instructions for filing can be found in the User Manual on the E-Dockets help page. Documents may also be submitted, in Word or PDF format, as an attachment to an email sent to mpscedockets@michigan.gov. If you require assistance prior to e-filing, contact Commission staff at (517) 241-6180 or by e-mail at mpscedockets@michigan.gov.

Any person wishing to intervene and become a party to the case shall electronically file a petition to intervene with this Commission by June 1, 2010. (Interested persons may elect to file using the traditional paper format.) The proof of service shall indicate service upon Detroit Edison's attorney, Jon P. Christinidis, One Energy Plaza, Detroit Michigan, 48226.

Any person wishing to make a statement of position without becoming a party to the case, may participate by filing an appearance. To file an appearance, the individual must attend the hearing and advise the presiding administrative law judge of his or her wish to make a statement of position. All information submitted to the Commission in this matter will become public information: available on the Michigan Public Service Commission's Web site, and subject to disclosure.

Requests for adjournment must be made pursuant to the Commission's Rules of Practice and Procedure R 460.17315 and R 460.17335. Requests for further information on adjournment should be directed to (517) 241-6060.
