## **PUBLIC HEARING:**

Scott Ellis, 1207 Van Deusen Drive, Staff at Avalon Housing spoke in support of the proposed project, homelessness has increased in Washtenaw County 20% since 2020 and housing first models have demonstrated success.

Gabe Grossman, 722 East Kingsley Vice President of Outreach at University of Michigan Urbanism Club, spoke in support of the proposed project. Adding he would like to see developments like this fit more into zoning ordinances.

Ken Garber 28 Haverhill Court, spoke in support of the proposed project, and shared local history regarding the origin of Avalon Housing as an outgrowth of housing protests in 1990. Mr. Garber requested information

about heating source of furnaces.

Amanda Carlisle, 1619 Waltham Drive, Washtenaw Housing Alliance, spoke in support of the proposed project, noting affordable housing need in Washtenaw County.
