*Assistant City Attorney Mary Fales was instructed to prepare a resolution to Council on Tuesday, February 19, setting a liquor committee hearing for March 6, 2013, based on the committee's discussion. It was decided that staff could amend the resolution prior to February 19 if any applicants satisfied the staff objections.*

*Councilmember Kailasapathy moved, seconded by Councilmember Anglin, that the Council Liquor License Committee recommend a hearing date be set by City Council for Wednesday, March 6, 2013 for hearing the above matters. All other liquor license applications were approved for annual renewal. On a voice vote, the motion carried.*
