3-Year Plan Review - Richard Wieland

Pauline will investigate whether the Arbor Day tree plantings are classified as contract expenses or maintenance/miscellaneous expenses, whether the tree contract is as required or constrained to specific years, and when the contract with Margolis expires.

Chairman Wieland believes that there should be money available should Adopt-A-Park ask for funding.

Treatment of the Wurster Park oak was discussed. Jacob says that the tree is approaching the end of its lifespan and that the treatment is likely a futile use of funds, and suggests replacing that oak with a new oak tree. Pauline will consult with Parks about possible succession planting.

Equity Planting Updates

Winewood Thaler Area - Jamie Pauline

Pauline confirmed with Margolis that they will be able to fit this project, along with the Housing Commission-adjacent project, into their spring planting schedule.

Housing Commission Plantings - Jamie Pauline

Updated information indicates that 29 of 37 identified sites can be planted, two of which will be delayed due to landscaping plans at the adjacent Housing Commission property. Eliminated sites were either unplantable or had already been planted.

Bus Stop Plantings - Jamie Pauline

Member Nybell moved to authorize an amount not exceeding \$20,000 for the planting and watering of 34 trees at bus stops throughout the City of Ann Arbor. Member Curtis seconded the motion. Motion was approved unanimously.

Gallup Park Sign - Laurie Tabachnik

- -Tabachnik suggested holding the ribbon-cutting ceremony in the spring. The committee is considering making the sign unveiling into an Arbor Day event.
- -The sign will be installed in the spring once the weather is appropriate for installation.

Member Nybell motioned to authorize up to \$1,000 to plant two trees near the Gallup Park Elizabeth Dean Grove. Member Sundy seconded the motion. Motion passed unanimously.

Temporary Signage - Laurie Tabachnik

Tabachnik conveyed feedback on the temporary signage for EDFC plantings.

- -Add comment "in partnership with the City of Ann Arbor"
- -Add Parks and Recreation logo
- -Add line: "For more information, please scan the QR code below."
- -Accessibility: Font should be sans serif and at least 18 points. Sentence case should be used.
- -Consult with department handling right-of-way management.

Members Nybell and Sundy left at 10:29am. Quorum was lost.

Elm Tree Treatments - Jamie Pauline

Jacob stated that he believes elms greater than 35 inches DBH and American and red elms are most susceptible to Dutch elm disease.

Committee plans to select 9 trees to treat, staggering treatments so that 3 trees are treated annually. Pauline and Jacob will meet to discuss the selection process. If necessary, a proposal will be sent to bid.

Adopt-A-Park Outreach - Brooks Curtis

Dana Novak will send out an inquiry to Adopt-A-Park volunteers to see what trees they want. Information should be available at the next EDFC meeting.

Member Curtis stated that parks in economically disadvantaged communities are less likely to have Adopt-A-Park volunteers. Pauline will

follow up by identifying parks in economically disadvantaged areas.
