*Election Commissioners discussed the State's Open Carry gun law and the rules regarding guns in the Ann Arbor Public Schools on Election Day.*

*City Clerk Jacqueline Beaudry updated the Commission regarding the Mary Street Polling Place and the 100 feet no campaigning rule, noting that the polling place is sitting on a 60 feet wide lot. In previous elections, signs have been placed in the neighbors windows, within the 100 feet.*

*Attorney Stephen Postema stated because it is private property and free speech, the City really can't enforce the 100 feet rule in this case. Beaudry noted that the City's Public Services places the "no campaigning" signs at the edge of the Mary Street property. A call to the Bureau of Elections for further guidance was not returned.*
