SAFETY NOTES

Safety Update The passing of Memorial Day marks the unofficial start of summer, and with it comes hot weather. You can be prepared for warmer weather by taking some simple precautions and by making use of some resources. The CDC's <u>Heat Risk</u> website allows you to enter your zip code to get today's heat risk rating, along with helpful tips. In addition, the Washtenaw County <u>Health Department</u> has safety tips, and a listing of local cooling sites for those who may need a place to go to cool off. Some simple things you can do to stay prepared for warm weather include:

- Limit your exposure by performing physically demanding work or exercise during the cooler hours of morning and evening.
- If you must be outside during the peak heat, schedule frequent rest periods with water breaks in shaded or air-conditioned areas.
- Be able to recognize the <u>signs and symptoms</u> of heat stress: heat cramps, heat exhaustion, and heat stroke.
- Drink plenty of cool water and hydrating liquids with electrolytes and wear breathable clothing when possible that minimizes heat stress.

- City officials break ground on fire station No. 4: A ceremony took place May 20 to break ground on the new City of Ann Arbor Fire Station No. 4, to be located on the same parcel as the current building, at South Huron Parkway and Platt Road. The new facility will be the first carbon-neutral city building and the first net-zero fire station in Michigan, featuring geothermal heating and cooling, solar panels and other energy-efficiency measures. The current fire station on the site is nearly 60 years old and, in addition to being energy inefficient, lacks adequate areas for contemporary firefighting equipment and for personnel, including gender-appropriate facilities. Once opened, Ann Arbor Fire Station No. 4 will also receive a new name, in honor of Ann Arbor's first female firefighter, Mindy Kerr, who served with the Ann Arbor Fire Department from 1980 until she retired in 2005.
- Solarize Ann Arbor: Have you considered solar and/or battery storage to reduce your emissions, reduce your energy bills, move toward energy independence, or to power your new e-bike or electric vehicle? Solarize Ann Arbor has groups running now! Join your fellow Ann Arbor area residents to learn about solar and for the opportunity for savings from the bulk-buy elements in Solarize. - The City of Ann Arbor has been named to the 2024 CDP A List, the top status available from the largest global independent environmental disclosure system, recognizing global leadership in environmental transparency, climate action, and resilience planning. Only 112 cities worldwide, or 15% of the CDP's scored cities, earned the top status of an A score. And, Ann Arbor is only one of 29 US cities to receive an A!
- Ann Arbor one of two cities to receive Platinum Status from the Michigan Green Communities Challenge: The MGC Challenge is an annual program that serves as a guide to help communities measure their progress towards sustainability. This is the first year the Platinum certification has been offered, and recognizes only two cities achieving that status, demonstrating Ann Arbor and Grand Rapids' unique commitment and dedication to creating a sustainable community.
- A²ZERO Partners with AFC Ann Arbor to Promote Sustainability and Youth Access to Sports: In a meaningful collaboration between environmental action and community engagement, the City of Ann Arbor Office of Sustainability and Innovations (OSI) is proud to announce its sponsorship of AFC Ann Arbor's 2025 season. AFC is Ann Arbor's hometown soccer team and has been working to advance the sustainability of their operations.
