## UNFINISHED BUSINESS

### Annual Renewal of Liquor Licenses

*Deputy city clerk Jennifer Alexa reported that 103 businesses have paid their annual liquor license renewal fees to date.*

*City Treasurer Mike Pettigrew stated several businesses still owe the City personal property taxes, including Banfield's Bar and Grill (\$722.19), Cafe Zola (\$2725.63), Nagomi Sushi (\$2101.51), Shalimar (\$1325.49), Silvio's Pizza (\$407.74) and Zola Bistro (\$1329.51). Mr. Pettigrew stated he has a payment arrangement with Silvio's Pizza and they have the option to pursue civil action with the other businesses, if necessary. Mr. Pettigrew stated no further action from the committee is requested at this time.*

*Councilmember Griswold moved, supported by Councilmember Song, that the Committee authorize the City Clerk's Office to continue to mail annual renewal letters and certificates to businesses who are paid in full and approved for the year. On a voice vote, the motion carried.*
