The Updated FY 2026-2031 CIP is a plan for City capital investments to be undertaken over the next six years. This plan describes projects that address needs for municipal and park facilities, transportation, utilities, and other infrastructure improvements, along with proposed costs and scheduling. Upon adoption by the City Planning Commission, the CIP becomes a supporting document for the City's comprehensive plan and is a source document for the City's capital budget planning.

## STAFF PRESENTATION:

Kayla Coleman, Capital Projects Asset Manager, presented the proposed request.

Moved by Commissioner Lee seconded by Commissioner Mills in that

Whereas, Section 1:185 of the Ann Arbor City Code requires that the City Planning Commission annually prepare a Capital Improvements Plan (CIP), identifying public improvements that will be needed within the ensuing six years, in the general order of priority;

Whereas, The FY2026-2031 Capital Improvements Plan (CIP) was approved by the Ann Arbor City Planning Commission on January 7, 2025;

Whereas, The Ann Arbor City Council approved the FY2026 Capital Budget on May 19, 2025 which used the FY2026-2031 Capital Plan as its basis:

Whereas, The second year of the FY2026-2031 CIP has been adjusted based on current conditions as related to the adjusted FY2027 Capital Budget to be considered by the City Council;

Whereas, Sunset (Brooks to Newport) Sidewalks (TR-AT-18-13) was added to the CIP at Planning Commission's request, which scored at a combined score ranking of 21 out of 44, resulting in programming for anticipated construction in 2029, and resulting in Jones (Plymouth to Broadway) Sidewalk (TR-AT-18-06) being delayed to beyond the 6-year capital planning period; and

Resolved, That the City Planning Commission hereby approves the Updated FY2026-2031 Capital Improvements Plan as a supporting document for the City's Comprehensive Plan; and

Resolved, That the City Planning Commission recommends that City Council approve the FY2027 Capital Budget, using the Updated FY2026-2031 Capital Improvements Plan as it's basis.
