#### 21-0246 HRC January Meeting Minutes

A motion was made by J. Garber, seconded by L. Winkler, that the Minutes be Approved by the Commission and forwarded to the City Council and should be returned by 3/15/2021. On a voice vote, the Chair declared the motion carried.

Commissioners J Garber and K Cowan volunteered to work with Denise to create a database of complaints received by the HRC during the past five years.

## C OLD BUSINESS

### NDO Ordinance Change - 180 day issue

Commissioners voted to send proposed changes to the Non-Discrimination Ordinance to Senior Assistant City Attorney Margaret Radabaugh for submission in appropriate form to Council. The proposed changes include the removal of the 180 day deadline to file discrimination complaints with the HRC and moving where the word "ethnicity" appears on the list of protected classes.

### Fair Chance Access to Housing Ordinance (Approval including Resolution)

L. Stambaugh discussed the final version of the Fair Chance Housing Access to Housing Ordinance, and the resolution explaining why Council should adopt the proposed ordinance. Commissioners voted unanimously to approve the proposed ordinance (and resolution) as written and asked CM T. Radina and CM E. Nelson to sponsor it at Council.

## **Conversion Therapy Ordinance**

Senior Assistant City Attorney Margaret Radabaugh is working on broadening the ordinance language to also protect Ann Arbor youth who are treated by licensed therapists who don't live in Ann Arbor. CM T. Radina recommended that the Mayor's new LGBTQ Liaison Naomi Goldberg review the final ordinance and resolution draft before the commission takes a final vote on them.

#### **Planning Strategic Planning**

L. Stambaugh requested that commissioners complete and return to her by February 17th the strategic planning worksheets she created in preparation for a strategic planning meeting the HRC will have soon.
