Building permit was submitted on May 19, 2016 for an interior demolition and mold remediation and rebuild with 4 stories of office space and 1 mezzanine.

The contractor Mr. Carlson has said that they expect to close on the sale on June 13, 2016 and they are working with the Planning Department on the 900 sq ft addition.
