station/convenience store building located at 1420 East Stadium
Boulevard, relocate the gas station pump island and construct a new
4,000-square foot retail building and pump island canopy on this 0.86 acre
parcel. Two curb cuts are proposed to be removed: one on Packard and
one on Stadium. A variance is being requested from the required drive

<u>City Initiated Annexation and Zoning-Braun Park</u> - Northern and Southern Section - Ann Arbor Township sold to the City of Ann Arbor approximately 10.5 acres of parkland located on the west side of Chalmers Road at 1200 and 1400 Chalmers Road. The property is planned to remain a natural area and will be maintained in conjunction with the Huron Parkway Nature Area. A portion of Mallets Creek also flows through this site. The two (2) parcels need to be annexed into the City of Ann Arbor and Zoned PL (Public Land). (Ward 2) Staff Recommendation: Approval
