NOTICE OF PUBLIC HEARING MILL CREEK TOWNHOMES REZONING (3002 CHELSEA CIRCLE)

The Ann Arbor City Council will conduct a public hearing at 7:00 p.m. on Monday, December 20, 2021 to hear all those interested in the proposed Ordinance No. ORD-21-34 — Mill Creek Townhomes Rezoning. This ordinance will zone 32.6 Acres from R3 (Townhouse Dwelling) to R4B (Multiple-Family Dwelling), Mill Creek Townhomes at 3002 Chelsea Circle.

The proposal would amend the City Zoning Map, which is a part of Section 5:10.2 of Chapter 55, Title V of the Ann Arbor City Code.
