Please take notice that pursuant to Public Act 198 of 1974, MCL 207.551 *et seq.*, on **January 3, 2022**, the Ann Arbor City Council will conduct a public hearing to consider the establishment of an industrial development district for land that is currently owned by **Sartorius BioAnalytical Instruments, Inc.** The property to be considered for inclusion in the district consists of Sartorius BioAnalytical Instruments, Inc. owned parcels that are commonly known as 3874, 3990, 3886, 3994, 3950, 3958 Research Park Drive, having tax identification numbers 09-12-09-303-012, 09-12-09-303-003, 09-12-09-303-011, 09-12-09-303-010, and 09-12-09-303-015 respectively, containing approximately 16.90 acres of land.
