Good Afternoon,

We are writing with a concern regarding the maintenance of the tree line along the railroad tracks at the intersection of Traver and Bowen Streets (adjacent to [REDACTED] [REDACTED]). Last weekend, a tree fell from the railroad's property, striking our home. This is one of multiple trees that have fallen in recent years, and many that are still standing are rotting.

When we moved into our home in 2014, the tree line between our home and the railroad was lush and full of trees and provided a buffer against the noise of passing trains as well as a buffer from the pesticides sprayed by the company. Now, the area has become an eyesore, full of dead and rotting trees. As you will see from the attached photos, not only is this visible from our home, but it is clearly visible from the street. As you are aware, we are in a historic district, across from the oldest

schoolhouse in Ann Arbor. What has become a depository of dead, rotting trees and discarded wood distracts heavily from the charm of the neighborhood. Further, our child and the nieces and nephews of the owner of the other adjacent property play frequently on the property, and this area has become a danger to them.

In driving around the neighborhood, we notice that this area appears to be an exception. For example, the area by the tracks at the intersection of Argo and Wright Streets appears relatively kempt and cared for.

We have a meeting scheduled at [REDACTED] with the Ann Arbor Railroad on Tuesday, December 21, at 12pm which we are hoping you can attend. If you are not able to do so, we hope you will advise us on the best way to proceed. We have reached out to the railroad, but they have thus far said they have no obligation to maintain the property.
